NOTICE OF PROCEDURAL SCHEDULE REVISIONS

RE: *In the Matter of Determining the Proper Carrier Classification of Glacier Recycle, LLC; Hungry Buzzard Recovery, LLC; and T&T Recovery, Inc.*, Docket TG-072226

TO ALL PARTIES:

On January 28, 2008, the Washington Utilities and Transportation Commission (Commission) entered Order 02 – *Prehearing Conference Order* in this matter. Order 02 set out the procedural schedule for this docket, including a deadline of July 22, 2008, for the submission of Staff and Intervenor Pre-Filed Direct Testimony.

On July 14, 2008, Commission Staff requested a two week continuance of each of the remaining deadlines in this matter. Staff’s request stated that all parties had been consulted and were in agreement with the request. Staff’s request also noted an ongoing exploration of a negotiated resolution to the case with all parties, possibly leading to an additional request to suspend the procedural schedule.

Staff’s request to extend the existing procedural schedule with regard to filing of testimony is granted. The request complies with the requirements in WAC 480-07-385 for such requests, and will not prejudice the parties or the Commission. The Commission revises the procedural schedule follows:

Pre-Filed Direct Testimony – Staff & Intervenors August 5, 2008

Pre-Filed Rebuttal Testimony – Respondent Companies August 22, 2008

At this time, the remaining deadlines in the procedural schedule, including the hearing on the merits scheduled for September 9-11, 2008, shall remain in place.

An updated "Appendix B" to Order 02 is attached to this Notice and supplants that previously issued with Order 02. All other provisions of Order 02 remain in effect.
