Pursuant to RCW 80.28.050 and 80.28.060 and the Washington Utilities and Transportation Commission's ("Commission") Rules and Regulations, PacifiCorp dba Pacific Power ("PacifiCorp" or "the Company") transmits for filing and approval by the Commission three copies of proposed new tariff sheets applicable to electric service supplied by the Company in the state of Washington to become effective on March 11, 2009. In accordance with WAC 480-07-510(2), this copy is provided in legislative format.

By the enclosed tariff sheets, PacifiCorp requests an increase in revenues from Washington operations resulting in an overall price change of 15.1% or \$38.5 million. The proposed new tariff sheets are contained in Exhibit No.__(WRG-2) accompanying this filing. The filing is based upon an historical test period of the twelve months ended June 30, 2008, adjusted for known and measurable changes.

PacifiCorp is also seeking to recover deferred costs associated with the Chehalis natural gas plant by consolidating the deferral with the existing rate Schedule 96, the Hydro Deferral Surcharge and renaming it the Deferral Amortization Surcharge. The Company proposes to amortize the balance in the surcharge account using the current collection rate. As such, no rate change is currently proposed for the present Schedule 96 rates.

Also enclosed pursuant to WAC 480-07-510(1) are nineteen (19) paper copies of the Company's Application and all testimony and exhibits that the Company intends to present as its direct case if the filing is suspended and a hearing held. One copy of the testimony and exhibits in electronic format is also included. Please note that certain of the exhibits are marked as "confidential" and are provided confidentially in accordance with the requirements of WAC 480-07-160(3). The confidential exhibits in this case are as follows: Bruce N. Williams (BNW-8C; BNW-9C); Mark R. Tallman (MRT-3C; MRT-4C; MRT-5C); Stefan A. Bird (SAB-5C; SAB-6C; SAB-7C); Gregory N. Duvall (GND-3C); and R. Bryce Dalley (RBD-4C). When a docket number is assigned, the Company will file a request for a protective order in accordance with WAC 480-07-420 to cover these confidential exhibits.

As required by WAC 480-07-510(3), enclosed please find copies of supporting workpapers, which, due to the considerable size of the documents, have been provided in electronic format on an enclosed CD. Certain of the workpapers/models are confidential; the Company is

following the same procedures with respect to this information as with the confidential exhibits. Paper copies will be supplied upon request.

As required by WAC 480-07-510(7), also enclosed are one copy of the following, as applicable: the most recent annual report to shareholders; the Company's most recent FERC Form 1; and the Company's Form 10Ks, Form 10Qs, prospectuses for any issuances of securities, and quarterly reports to shareholders (if any) for the most recent two years prior to the filing date.

The Company waives its right to have this filing considered at an open meeting of the Commission as set forth in RCW 80.04.130(1) and consents to the Commission's prompt entry of an order suspending the filing and commencing an investigation. The Company agrees that upon suspension of its tariff filing, it will provide notice pursuant to WAC 480-100-197. Accordingly, the notice provisions of WAC 480-100-194 are not required for this filing.
