NOTICE ESTABLISHING DEADLINE TO RESPOND TO JOINT PETITION TO INITIATE AN ADJUDICATIVE PROCEEDING

(By Monday, November 5, 2018, at 5 p.m.)

RE: Puget Sound Energy's Proposed Sale of Non-Controlling Interest in Puget Holdings LLC Docket U-180680

TO ALL INTERESTED PERSONS:

On September 5, 2018, Puget Sound Energy (PSE or Company), jointly with Alberta Investment Management Corporation, British Columbia Investment Management Corporation, OMERS Administration Corporation, and PGGM Vermogensbeheer B.V., filed with the Washington Utilities and Transportation Commission (Commission) an application for approval to sell a non-controlling interest in Puget Holdings LLC (PSE's Application).

On September 21, 2018, the Commission issued a notice of opportunity to file written comments and notice of recessed open meeting, scheduled for Monday, November 5, 2018, at 9:30 a.m. The notice stated that interested persons may file written comments regarding PSE's Application with the Commission no later than October 24, 2018. The notice further stated that the Commission will address the proposed sale and accept comments on the Application from the public at the recessed open meeting.

On October 24, 2018, Public Counsel, the Alliance of Western Energy Consumers, The Energy Project, and the Washington and Northern Idaho District Council of Laborers filed a joint petition (Joint Petition) requesting the Commission initiate an adjudicative proceeding to review the transaction described in PSE's Application.

Washington Administrative Code 480-07-370 provides that responses to a petition must be filed within 20 days after the petition is filed, unless the Commission establishes a different deadline. By this notice, the Commission establishes a deadline of 5 p.m., Monday,

November 5, 2018, to file responses to the Joint Petition. In addition, the Commission encourages interested persons to present oral responses to the Joint Petition at the recessed open meeting scheduled for Monday, November 5, 2018, at 9:30 a.m.

THE COMMISSION GIVES NOTICE That the deadline to file a response to the Joint Petition requesting the Commission institute an adjudicative proceeding is 5 p.m. on Monday, November 5, 2018. In addition, interested persons are encouraged to present oral responses to the Joint Petition at the recessed open meeting, scheduled for Monday, November 5, 2018, at 9:30 a.m.
