Thank you for circulating the updated commitments. They accurately reflect my understanding of the consensus reached by all of the stakeholders. Public Counsel is ready to file comments tomorrow that support the consensus, present our view of Commitment 43, and state on the record our discomfort with the level of detail provided in discovery. As we have consistently expressed during the course of our discussions, we remained uncomfortable with the level of detail – and the resulting impact on risk and harm/no-harm analysis – throughout this process, and need to state this on the record. We recognize that the agreed modifications to the commitments are in the public interest and that consensus on the vast majority of the commitments likely negates the need to litigate or take other action on our discomfort. We appreciate the agreements made by the Joint Applicants, including the most recent movement on Commitment 39.

I want to check expectations to see if mine matches yours. I anticipate that the updated commitments will be filed tomorrow (Friday, 1/7). Assuming stakeholders respond to your message, is that what you anticipate as well? I think the modified commitments need to be filed before stakeholders can file comments that discuss them.
