On October 5, 2005, the Company submitted filings under Company advice numbers 2005-43 and 2005-44 which were assigned Docket Nos. UE-051527 and UG-051528 respectively.

By this letter and pursuant to WAC 480-80-131, the Company respectfully requests withdrawal of the October 5, 2005, submittals under Docket Nos. UE-051527 and UG-051528. The filing in Docket No. UE-051527 included twenty-four tariff sheets from the Company's WN U-60 (electric) tariff. The filing in Docket No. UG-051528 included fourteen tariff sheets from the Company's WN U-2 (natural gas) tariff.

This request for withdrawal of the above-described filings is being made as a result of the Commission's approval of an Order authorizing deferral and future recovery of costs instead of the recovery proposed in these tariffs.
