Pursuant to the Thirteenth Supplemental Order in Docket Nos. UE-011570 and UG-011571, please find enclosed the Report of Weighted Average Cost of Propane Fuel Inventory for the three months ended December 2009, for Puget Sound Energy, Inc. ("PSE" or "the Company").

The weighted average cost to the Company of propane fuel inventory at the end of the fourth quarter of 2009 was $\$ 3.81228$ per therm. The weighted average cost of propane charged to customers under the provisions of Schedule 101 during the same period was $\$ 3.35091$ per therm. Therefore, effective February 1, 2010, the weighted average cost of propane charged to customers will change to $\$ 3.81228$ which is within the approved banded rate.
