The request seeks to increase the basic access charge for service to consumers over 2024 and 2025. In reflecting on our gas services bills for the last four years, our rate has increased an astronomical amount. We live in the same home, built in 2015, and beginning in May 2022, we have one less individual residing in our home. The average temperature has been quite similar year over year. In January 2020, our gas bill was \$121.50 and average Therm price for our home was \$.081. In January 2024, our gas bill is \$287.85 and average Therm price \$1.44 for our home. Note that in these two comparing years. the average temperature for the month of January 2020 was actually 2 degrees colder. As a working, middle-class family of five, we are being priced out of our home and potentially Washington State. This adds incredible burden of vehicle and home insurance that has more than doubled for residents as well. Natural gas price has fallen significantly. At a time when many companies are providing rebates and lowering the price of utilities for consumers, Avista is filing to increase rates, again. In our neighborhood, we are not provided options to utilize for utility companies and Avista has a monopoly strong hold on us. Mary Arlt	Mail	To Whom It May Concern: There was another notice in my recent Avista bill about another rate increase. Is this a monthly or quarterly thing now? Yes I am against another rate increase of any kind. Now they want an increase for connections to the system of \$3.27 per month {3.5%} if connected before July 25, 2021 and a 16% or \$14.76 per month increase for connections after that. We are already looking at a 3.1% rate increase in July of 2025 and there was a 3.2% increase last July. All this is based on using 64 therms a month. I looked at my 2023 bills. In January I used 154,944 for \$200.95; February 137.771 for \$178.69; March I used 92.389 therms for \$119.85; April 44.963 for \$63.97 (which also included a New Rate line); October 57.389 therms for \$89.98; November 132.251 therms for \$200.16 and December 134.379 for \$204.13. I am totally afraid of what January's usage will be with this very cold weather.

During the recent cold snap I had the free standing gas stove in the living room on for 5 days but turned it and the pilot light off yesterday to use less gas. I looked at my Avista account estimates and freaked. When I checked on the discount program, I make a little too much in my retirement income to qualify for any discounts. So guess I am stuck paying very high bills to Avista. Today's minimum wage is probably more than what many people my age retired on. Today's retirees are competing with Avista wages and minimum. Hard to do. Avista seems more concerned about getting the shareholders money than they are about budgeting for updates, etc. They have stuck everything onto the rate payers. Hopefully you all will do your job and say no. Kathleen Ewart To Whom It May Concern: Mail It has come to our attention that Avista Utility has requested an increase in rates. I am requesting that you deny that request. Further, I do not know whether you have input regarding the breaching of the dams. If you do have any influence please do not allow this. Washington State residents rely on hydroelectricity. Fish can be farmed, but electricity cannot. My husband and I live on our pensions. We received a small increase in our allotment, however, the beginning of 2024 we have learned the following; our home owner's insurance had gone up; our car insurance has gone up; our local Millwood water bill is increasing; our phone bill is increasing and my Medicare Part D went up \$8.00. Our last payment for services to Avista was \$260.00, and that was before the cold snap, and we won't even talk about what has happened to groceries and notions. Between the two of us we pay \$848.00 per month in medical insurance (not including Dental insurance which we pay separately) The above amount includes our Medicare which is automatically taken out each month. I respectfully request that you do not allow an increase. Please draw the line. Unlike persons still working we cannot demand a 25% increase in our pay, yet we are competing with those people for goods and services. I thank you for your consideration of this request. Aaron Whiteman Avista is proposing an increase in the basic connection from the existing \$10 per utility to \$15, and Web then \$20. This means for a customer that uses gas and electricity, the customer would be paying \$40, without using any energy. My household fits this use case. I recently moved from a Natural gas stove to Induction, primarily for environmental reasons. However, since my furnace is natural gas, I still need to maintain a natural gas connection. Avista is rewarding my efforts to reduce my gas usage by increasing the component of my bill that I cannot control through efficiency. The only way I can prevent a 90% increase in my summer gas bill (when I effectively do not use natural gas) is to spend significant money to replace my gas

As a customer and member of the community, I am troubled by the implications this increase will have on individuals and families who rely on affordable electricity to meet their basic needs. Furthermore, I was shocked to discover after moving only 10 miles that my electricity bill is already more than \$20 higher than that of Spokane Valley. This substantial cost difference raises questions about the fairness and justification of Avista rate increases, particularly compared to a service provider only 10 miles away. In addition to this disparity, I recently learned that Avista Corp pays a total dividend payment of \$139,840,000 yearly. While I understand the importance of rewarding shareholders, it isn't easy to reconcile this substantial dividend payout with the company's claims of needing additional funds for repairs and maintenance. It seems unjustifiable to burden customers with higher rates under such
		circumstances, especially when Avista Corp is already allocating significant sums to shareholders. Many individuals and families are already facing economic challenges, particularly after recent global events. Forcing them to shoulder additional expenses for essential services like electricity only

It supposedly lowers the price at the distributor, three full links away from the customer. Since I was not aware of this change - from customer to distributor - I was misinformed by the company salesman in a way that made sense based upon my previous experience with Avista rebates. 		Now, I'm shaking as I look at our latest bill, the Dec-Jan cycle of 2023-2024, of \$348! Instead of us splitting a bill of \$166, now we're both paying(more than) that, each!
		Two people cannot make that much of a change and the temps aren't even as cold as last year for this to be attributed to our usage.
		We couldn't even do laundry during the freezing temps because the drain freezes, so the dryer wasn't used. I'm looking at "electric heating" usage of \$80, and we don't have electric heat, so I don't even know what that's about.
		All the more galling, Avista has been sending non-stop "You may be looking for ways to manage your energy bill" emails since before we even received the bill, so that just seems like damage control for what they know is price-gouging, by telling me it's my fault, when it's clearly a matter of greed.
