SOLID WASTE COLLECTION SERVICE In that portion of Spokane County described as follows: Commencing at the Washington-Idaho State line at the northeast corner of Section 6, T24N, R46E; thence west to the northwest corner of Section 6, T24N, R45E; thence south to the southwest corner of Section 7, T24N, R45E; thence west to the northwest corner of Section 15, T24N, R44E; thence south to the southwest corner of Section 15, T24N, R44E; thence west to the northwest corner of Section 19, T24N, R 44E; thence south to the northwest corner of Section 6, T23N, R44E; thence west to the northwest corner of Section 4, T23N, R43E; thence south to the southwest corner of Section 33, T21N, R43E, also the Spokane-Whitman County line; thence east on the Spokane-Whitman County line to the Washington-Idaho State line on the 5th Standard Parallel to the southeast corner of Section 31, T21N, R46E; thence north along the Washington-Idaho State line to the northeast corner of Section 6, T24N, R46E, the point of beginning.

SOLID WASTE COLLECTION SERVICE in all of Whitman County EXCLUDING the following portions: In that portion of Whitman County described as follows: T20N, R39E; Also, beginning at the northeast corner of Section 24, T15N, R45E; thence west along the north line of said Section 24 extended to the northwest corner of Section 22, T15N, R44E; thence south along the west line of said Section 22 extended to the southwest corner of Section 22, T14N, R44E; thence east along the south line of said Section to the southeast corner of said Section 22; thence south along the east line of said Section 22 extended to the southwest corner of Section 35, T14N, R44E; thence east along the south line of said

Solid Waste Collection Service in that portion of Spokane County described as follows:

Sections 35 and 36, T22N, R42E. Sections 29, 31, and 32, T22N, R43E. Sections 24, 25, and 36, T24N, R43E. Sections 16 and 17, T24N, R44E. Northern half of Section 11, T24N, R44E. Northern halves of Sections 32 through 36, T25N, R45E. Northern half of Section 31, T25N, R46E.

The following authority was transferred to Certificate No. G-237; Certificate No. G-75 no longer authorizes solid waste collection service in that portion of Spokane County described as follows:

Section 6, T24N, R45E, and Section 7, T24N, R45E.
