SECTION A

RULES AND REGULATIONS

RULE NO.

1

APPLICATION OF FARES:

- (A) The fares authorized herein are Adult One-Way Fares and Roundtrip Fares, and are payable in lawful United States money.
- (B) The fares named herein may be used as Basing Fares to construct Fares to and from points beyond the stations named herein.
- (C) The fares between intermediate points not specifically named herein, will not exceed the Fares named herein.

Tickets will be on sale daily.

REDEMPTION OF TICKETS:

- (A) A Refund of the difference between the One-Way Fare and the Roundtrip Fare Paid, will be allowed on a totally unused return portion of a Roundtrip Ticket, less a Fifteen (15%) Percent Refund Service Charge.
- (B) A totally unused ticket will be redeemed to the Original Purchaser at the Fare Paid less a Fifteen (15%) Percent Refund Service Charge.
- (C) No Refund will be allowed on a partially used One-Way Ticket or on a Roundtrip Ticket where a part of the return portion has been used.

RULE NO.

- 4 OTHER DISCOUNTS:**
(A) Senior Citizens are those you have reached or surpassed the age of Fifty-Five (55).
(B) Senior Citizens will receive a Ten Percent (10%) Discount on both one-way and roundtrip fares.
(C) Children who are two years old to eleven years old and between (2-11) will receive a Forty Percent (40%) Discount provided they are traveling with one full fare paying adult.
(D) One child under the age of two will travel for free provided they are traveling with one full fare paying adult.
- 5 BAGGAGE AND EXPRESS CLAIMS:**
Baggage and Express claims will be processed according to the rules and regulations as specified in the National Baggage Tariff A-500 and National Express Tariff A-600 as filed by the National Bus Traffic Association.
