- On July 23, 2004, Pennco Transportation, Inc., filed an application (No. D-079294) for an extension of Certificate No. C-01054 for a Certificate of Public Convenience and Necessity to Operate Motor Vehicles in Furnishing Passenger and Express Service as an Auto Transportation Company (Application). Notice of the Application was published in the Commission's weekly Docket of August 30, 2004.
- The Application request the authority be revised to include door-to-door passenger service, by reservation only, between Clallam and Jefferson Counties and Seattle and Tacoma hotels and cruise terminals, between Clallam and Jefferson Counties and Kingston and Bainbridge Ferry Terminals, between Kitsap County and Seattle and Tacoma hospitals. Amtrak stations, Greyhound station, cruise terminals, hotels, and the Seattle-Tacoma International Airport with closed door service between Kitsap County and the indicate points in King and Pierce County, and between Kitsap County and Kingston and Bainbridge Ferry Terminals. Applicant is also requesting that the authority be revised to remove the following restriction to its door-to-door service:

Pennco may not provide service to passengers from any point served by Heckman Motors, Inc., d/b/a Olympic Bus Lines, under Certificate No. C-992 without advance reservations made at least one hour in advance of the pick-up times at each such point indicated by Heckman Motors, Inc.,

d/b/a Olympic Bus Lines, schedule as published from time-to-time in accordance with WAC 480-30-060.

Passenger Service between Clallam and Jefferson Counties and Kitsap County Ferry Terminals.

- The issues in this proceeding include whether the issuance of an extension of authority to Pennco Transportation, Inc., for the service it proposes is necessary and is otherwise consistent with the public interest, and whether other carriers are authorized to serve in the territory requested. The Commission has jurisdiction over this matter under Title 81 RCW, have legal authority to regulate persons seeking to furnish auto transportation services under chapters 81.68 RCW and 480-30 WAC.
