Discussion

On June 7, 2005, Yury and Aleksei Mironenko, General Partnership d/b/a Good Old Movers, filed Application No. P-79379, requesting permanent household goods authority.

The Commission granted the company temporary authority subject to conditions pending a decision on its application for permanent authority. The company has operated under Household Goods Carrier Permit No. HG-61841 since June 15, 2005.

Application No. P-79379 appeared on the Commission's June 20, 2005, application docket subject to comment for no less than 180 days while the company conducted operations under its temporary authority. No comments were received.

Under the provisions of WAC 480-15-330 the Commission will grant or deny an application for permanent authority after conducting a complete review of the application filing, supporting statements, reports, or other information necessary to determine fitness, public interest, and current or future public convenience and necessity.

Yury & Aleksei Mironenko, General Partners, have six years experience in the household goods moving industry. Neither partner has been convicted of a Class A or B felony or previously been denied authority based on fitness. Good Old Movers holds a valid UBI number and a revenue tax account.

Compliance staff worked with the company providing technical assistance during its temporary operations. Investigator Bruce Grimm completed a Safety Compliance Review and a Household Goods Technical Assistance and Records Review Checklist. Investigator Grimm found the company in general compliance and on February 13, 2006, he recommended the applicant be considered for permanent authority.

During the period of Investigator Grimm's review, the applicant performed four household goods moves. The Commission received no customer complaints regarding this company's service during the review period. Two customer survey questionnaires were returned to the Commission regarding Good Old Movers. The surveys indicated that the customers were satisfied with the company's service and would use them in the future.

Recommendation

P-79379 is an uncontested application and therefore no hearing is required. There are no outstanding issues that suggest staff should ask the Commission to set the application for hearing.

I recommend that Licensing Services Staff prepare an order to grant Application No. P-79379, without hearing and reissue Permit No. HG-61841 to Yury & Aleksei Mironenko, General Partnership d/b/a Good Old Movers, as unrestricted permanent authority to operate as a household goods carrier in the state of Washington.
