### RATE INCREASE NOTICE FOR ROLL-OFF SERVICE

Dear Customer:

December 30, 2010

Mason County Garbage Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC April 1, 2001. Since that time, the Company has experienced increases in operating costs in the areas of labor, employee benefits, fuel, parts and equipment amongst other categories which it now seeks to update in rates. In addition the Board of County Commissioners voted to increase the tipping fee by \$.64 per ton effective January 1, 2011.

If approved, the proposed rates will become effective February 1, 2011. The rate per haul will increase as follows:
