# PROJECT AGREEMENT GRADE CROSSING PROTECTIVE FUND

# A. PARTIES OF THE AGREEMENT

This project grant agreement is entered into between the Washington Utilities and Transportation Commission (UTC), P.O. Box 47250, Olympia, Washington 98504-7250, and Columbia Basin Railroad, 111 University Parkway, Suite 200, Yakima, WA 98901, and shall be binding upon the agents and all persons acting by or through the parties.

## B. PURPOSE OF THE AGREEMENT

This agreement sets out the terms and conditions by which grants are made from the Grade Crossing Protective Fund. These grants are administered by the UTC to the grantee for Docket No. TR-143139, identified above.

## C. DESCRIPTION OF PROJECT

TR-143139 involves replacement of crossbuck posts and crossbucks, replacement or installation of yield or stop signs and installation of retro-reflective tape at 49 public crossings on railroad lines in Grant, Franklin and Adams counties. The project also involves installation of "Tracks Out of Service" signs at 16 crossings (14 public and two private). See Appendix A which is attached to the Order 01 for a list of the crossings.

#### D. PERIOD OF PERFORMANCE

The project reimbursement period shall begin on October 30, 2014, and end May 30, 2015. No expenditure made before or after this period is eligible for reimbursement unless incorporated by written amendment into this agreement.

#### E. PROJECT FUNDING

Total grant funding awarded by the UTC for this project shall not exceed \$9,862.78. The total approximate cost of the project is \$9,862.78 excluding labor. Columbia Basin Railroad will be contributing the labor to install the signs. The grantee shall be responsible for all additional costs.

# F. RIGHTS AND OBLIGATIONS

All rights and obligations of the parties to this agreement are subject to this agreement and its attachments, including the grantee's application, Commission orders, and the general provisions, all of which are attached and incorporated into this agreement.

Except as provided, no alteration of any of the terms or conditions of this agreement will be effective unless provided in writing. All alterations must be signed by both parties.

The grantee has read, fully understands and agrees to be bound by all terms and conditions in these documents.

G. COMPLIANCE WITH APPLICABLE STATUTES, RULES, AND UTC POLICIES This agreement is governed by, and the grantee shall comply with, all applicable state and federal laws and regulations, including RCW 81.53.281, the published agency rules in 480-62 WAC, and the Commission's order in this matter which are incorporated by this reference as if fully set forth.
