Dear Mr. Johnson,

In accordance with WAC 480-80-104, Cascadia Water, LLC (“Cascadia”) hereby files with the Washington Utilities and Transportation Commission (the “Commission”) its Application for the Sale and Transfer of Assets from Monterra, Inc. (“Monterra”) to Cascadia (“Application”). Confidential documents are designated under the general protective order WAC 480-07-160, as further addressed in the accompanying Claim of Confidentiality, filed with this Application.

In connection with this Application, Cascadia further requests approval of a revised tariff for Cascadia. As more fully explained in the Application, Cascadia is adopting Monterra’s existing tariff unchanged, as reflected in the accompanying Exhibit 4. This approach ensures that customers will not be impacted by the proposed acquisition and that customers will have a seamless transition to Cascadia. While Cascadia understands that there may be a future need to conform the adopted tariff so that all customers are subject to the same rules, rates, and charges, Cascadia intends to address such changes on a consolidated basis in Cascadia’s next general rate case—thereby ensuring efficient and consistent review of all of Cascadia’s adopted tariffs.

As required by WAC 480-80-103(4)(a), I certify that Culley Lehman has the authority to issue tariff revisions on behalf of Cascadia.
