On June 3, 2019, the Washington Utilities and Transportation Commission ("WUTC") issued a Notice of Intent to Deny Application for Permanent Authority and Notice of Opportunity for Hearing ("Notice") in this Docket. The Notice included a June 15, 2019 deadline for Dolly, Inc ("Dolly") to contest the WUTC's intent to deny Dolly's application for permanent operating authority and request an adjudicative proceeding pursuant to chapter 34.05 RCW and chapter 480-07 WAC.

The Commission in its Notice pointed out certain deficiencies in Dolly's application, which Dolly overlooked. Dolly therefore wishes to withdraw its application at this time. This will not only allow Dolly to cure the deficiencies, but also prevent the unnecessary administrative burden of further review and adjudication.
