NOTICE RESCHEDULING BRIEF ADJUDICATIVE PROCEEDING (Now set for January 29, 2020, at 1:30 p.m.)

RE: In re Application of AmericaM Movers LLC for a Permit to Operate as a Motor Carrier of Household Goods Docket TV-190858

TO ALL PARTIES:

On October 14, 2019, AmericaM Movers LLC (AmericaM Movers or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for provisional and permanent authority to operate as a household goods carrier in the state of Washington (Application).

On November 13, 2019, the Commission issued a Notice of Intent to Deny Application for Permanent Authority and Notice of Opportunity for Hearing in this matter based on its review and investigation of the Application. The Notice provided AmericaM Movers the opportunity to request a hearing to contest the factual allegations by November 27, 2019.

On November 25, 2019, AmericaM Movers filed with the Commission a Request for Hearing.

On December 10, 2019, the Commission issued a Notice of Brief Adjudicative Proceeding set for January 7, 2020, at 9:30 a.m.

On December 23, 2019, the parties contacted the presiding administrative law judge and jointly requested the Commission to reschedule the brief adjudicative proceeding for the last week in January 2020, explaining that the Applicant intended to call a witness from Commission staff (Staff) who could not be made available on January 7, 2020.

After conferring with the presiding officer as to the Commission's availability, the parties indicated agreement to rescheduling the hearing in this matter to January 29, 2020, at 1:30 p.m.

The Commission finds good cause to reschedule the brief adjudicative proceeding to January 29, 2020, at 1:30 p.m. to allow the Staff witness to attend the hearing and testify.

Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a list enumerating and describing any such documents no later than 5 p.m. on Wednesday, January 22, 2020, and bring an original and (3) copies to the hearing. Filing shall be in accordance with WAC 480-07-140.

THE COMMISSION GIVES NOTICE That the brief adjudicative proceeding in Docket TV-190858 is rescheduled to Wednesday, January 29, 2020, beginning at 1:30 p.m., in the Commission's Richard Hemstad Hearing Room, 621 Woodland Square Loop SE, Lacey, Washington..
