The County has chosen to name this small section of new road (which is in effect realigned Butterfield Road) Butterfield Road so that there isn't a gap in Butterfield Road. If the County was to name this new roadway as Mill Parkway, there would be a section of Butterfield Road west of Mill Parkway and another section of Butterfield Road east of Mill Parkway.

The new at-grade crossing was completed on November 2, 2021 and is ready for WUTC inspection.
