Note 2: Rates named in this item apply for all hauls not exceeding 5 miles measured from the point of pickup to the disposal site. Excess miles shall be charged for at **\$ 2.55 (A)** per mile or fraction of a mile. Mileage charge is in addition to all regular charges.

Note 3: Permanent Service is defined as no less than scheduled, once a month pickup, unless local government requires more frequent service or unless putrescibles are involved.

Accessorial charges assessed (lids, tarping, unlocking, unlatching, etc.):

Note 4: A fee of **\$29.02 (A)** per pick up will be assessed when containers with attached compactors require disconnecting or reconnecting.

Note 5: A gate or obstruction charge of **\$13.43 (A)** per pick up will be assessed for opening, unlocking or closing gates or moving obstructions in order to pick up solid waste.
