Puget Sound Energy (“PSE”) submits in connection with Docket UE-200886 the following tariff sheet to replace the sheet that accompanied PSE’s initial October 27, 2020 filing submitted under PSE’s Advice No. 2020-38. The purpose of this substitute tariff sheet filing is to reflect the results of the Commission staff’s (“Staff”) review and the discussions between the Staff and PSE. PSE appreciates the Staff’s thoroughly review of the initial filing. The revised PSE’s Schedule 91 Price Models (“Models”); Model A-Standard Schedule 91 Rates for Delivery to PSE’s Distribution System and Model B-Standard Schedule 91 Rates for Delivery to PSE’s Transmission System; are also attached to this filing.

The tariff sheets described herein reflect an issue date of October 27, 2020, and an effective date of December 12, 2020. Notice and posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed in accordance with WAC 480-100-193(1). The tariff changes proposed in the filing do not increase recurring charges nor restrict access to the optional services under Schedule 91. No notice is required under the provisions of WAC 480-100-194 or -195.
