After consultation with Washington Utilities and Transportation Commission ("WUTC") Staff, Cascade Natural Gas Corporation ("Cascade") submits the following attached **revised** supplemental appendices to UG-210784, Application to Amend Certificate of Public Convenience and Necessity. The maps included in the appendices depict the area being added as well as the surrounding area with docket numbers for reference. The original supplemental maps did not have the current docket number UG-210784 on them. Cascade has also added the legal descriptions to each of the Appendices.
