**Accessorial charges assessed (lids, tarping, unlocking, unlatching, etc.):**

Note 2: A gate or obstruction charge of **\$12.23** will be assessed for opening, unlocking or closing gates, or moving obstructions in order to pick up solid waste.

Note 3: A fee of **\$26.17** per pick up will be assessed when containers with attached compactors require disconnecting or reconnecting.
