TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made toward rulemaking for permanent rules relating to chapter 480-75 WAC, establishing minimum safety standards and reporting requirements for the transportation of hazardous liquids by pipeline, and to provide notice of an opportunity to file written comments on the proposed rules and participate in the formal rule adoption hearing.

On June 5, 2002, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Code Reviser. A copy of the CR-102 is enclosed for your convenience. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

NOTICE is hereby given of the opportunity to submit written comments on the proposed rules to the Commission by filing with the Commission Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. Evergreen Park Drive S.W., P.O. Box 47250, Olympia, Washington, 98504-7250, no later than 5:00 p.m., Wednesday, June 26, 2002. Electronic copies. The Commission also requests, but does not require, that comments be provided in electronic format to facilitate quotations from the comments, to enhance public access, and to reduce the need for additional paper copies. Please help us by

sending an electronic copy with your paper filing on a 3-1/2 inch, IBM-formatted, high density disk, in .pdf Adobe Acrobat format, reflecting the pagination of your original. Please also send us the text in your choice of .doc (Word 97 or later) or .wpd (WordPerfect 6.0 or later). Please include all of the following information on the label of the diskette:

- * The docket number of this proceeding (TO-000712)
- * The commenting party's name
- * The title and date of the comment or comments; and
- * The type of software used

Please use the three-letter extension noted above for all electronic files. You may also send your comments by electronic mail to the Commission's Records Center at records@wutc.wa.gov; if you choose this means of submitting comments, please include all of the information requested above for the diskette label. The Commission will post on the Commission's web site all comments that are provided in electronic format. The web site is located at <http://www.wutc.wa.gov>.

NOTICE is also hereby given of the opportunity to attend the public hearing and make oral comments about the recommendation for the adoption of the proposed rules at 9:30 a.m., Wednesday, July 10, 2002.
