All My Sons Moving & Storage of Seattle, Inc. ("All My Sons") requests a hearing to contest the occurrence of the violations, or in the alternative request a mitigation of the amount of the penalties, set forth in Penalty Assessment No. 050537 (the "Penalty") for the following reasons (identified by paragraph number as used in the Penalty):

- 1-10 All My Sons does not deny that the violations regarding estimate forms technically occurred, but All My Sons was not advised during a prior audit to stop using the forms.
- The circumstances did not require supplemental estimates to be issued in each of the seven moves for which this penalty is based.
- WAC 480-15-680 as used for the assessment of the Penalty is in conflict with WAC 480-15-690 and should not support a penalty in this situation.
- All My Sons believes it can produce the estimate, or explain its absence, for two of the three moves where the estimate was not attached.
- 15 This penalty should be mitigated as no harm came to any shipper as a result of these oversights in filling in the forms.
- All My Sons does not deny that the violations regarding phone numbers technically occurred, but All My Sons was not advised during a prior audit to stop using the forms.
- 17 Two of these moves were not put into storage with All My Sons.
- 18-19 These penalties should be mitigated as no harm came to any shipper as a result of these oversights in filling in the forms.
