2. The referral from this Court to the Washington State Utilities and Transportation Commission is hereby withdrawn. All remaining legal or factual issues in this case are


withdrawn from the Commission's consideration and will be addressed by the Court. The parties shall notify the Commission of this order within five (5) court days.
