4 **Q. Please state your name and business address.**

5 A. My name is W. James Elsea. My business address is 10885 NE Fourth Street,
6 Bellevue, Washington, 98004-5591.

7 **Q. By whom are you employed and in what capacity?**

8 A. I am employed by Puget Sound Energy, Inc. ("PSE") as Financial Analysis
9 Manager of Energy Resources.

10 **Q. What are your duties as Financial Analysis Manager of Energy Resources?**

11 A. As Financial Analysis Manager of Energy Resources, I am responsible for the
12 analysis of individual power resources and portfolios of power resources for
13 PSE's Least Cost Plan and resource acquisition processes.

14 **Q. Briefly describe your education and relevant employment experience.**

15 A. I graduated from Colorado State University in 1973 with a Bachelor of Science
16 degree in forest hydrology. From 1973 to 1981, I was employed as a hydrologist
17 by the U.S. Forest Service. From 1982-1985, I was self-employed as a
18 woodworker in Seattle, Washington, specializing in custom-made cabinetry and

1 office furniture.

2 In 1986, I graduated from the University of Washington with a Masters in
3 Business Administration (MBA) degree with an emphasis in finance.

4 I joined Puget Sound Power & Light Company (“PSP&L”) in 1987 as a Financial
5 Analyst, in which position I modeled PSE’s capital budgeting and investment
6 decisions. In 1991, I became the Manager of Cost and Schedule for PSP&L’s
7 engineering project management group, in which position I provided construction
8 cost and schedule planning support to project management engineers building
9 substations and transmission lines.

10 From 1993-1996, I served as Manager Financial Planning, in which position I
11 managed a team preparing corporate financial forecasts and assisted in the
12 evaluation of financial forecasts for the merger between PSP&L and Washington
13 Natural Gas.

14 From 1997-2003, I served as Consulting Analyst providing Energy Supply
15 Forecasting in Energy Risk Management Group, in which position I (i) prepared
16 power cost forecasts; (ii) modeled open position for risk management;
17 (iii) developed analysis for acquisition and sale of resources (e.g., Encogen,
18 Centralia); (iv) participated in the 2001 rate case collaboratives that developed
19 PSE’s Power Cost Adjustment Mechanism and established revenue requirements;
20 and (v) assisted in the development of the revenue requirement logic for the
21 Portfolio Screening Model.
