You are further commanded to bring with you the following documents:

For the time period of January 1, 2010 to the present, all documents and other records relating to: communications or solicitations by Waste Management to provide medical waste and/or recycling collection, transportation, processing and treatment services to Valley Medical Center

or negotiations with Waste Management concerning such services. This request includes but is not limited to communications between Valley Medical Center (or Aramark on behalf of Valley Medical Center) and Waste Management or communications internal to Valley Medical Center (or Aramark on behalf of Valley Medical Center), including email communications.

In lieu of producing these documents at the deposition, you may mail a copy of the subpoenaed documents to legal counsel for Stericycle of Washington, Inc., together with your certification that the items produced are true and correct copies of the subpoenaed documents. If you choose to produce the subpoenaed documents by mailing them rather than producing them at the proceeding, the subpoenaed documents must be received by legal counsel for Stericycle of Washington, Inc. by a mutually agreeable date prior to the date set out above for the deposition.
