Dear Mr. Danner:

On April 16, 2010 the Washington Utilities and Transportation Commission (“WUTC”) issued a Final Order Approving and Adopting, Subject to Conditions, Multiparty Settlement Agreements and Authorizing Transaction (“Approval Order”). The Approval Order included a number of conditions which the Commission attached to that Approval.

One of those conditions required that, “Within 30 days of closing, Frontier NW shall deposit in a bank account, escrow account or other account as approved by the Commission \$40 million to fulfill the broadband commitment identified in paragraphs 13 to 18 . . .” (Approval Order, Appendix A, Condition 14.) This letter is to advise the Commission that on July 28, 2010, Frontier Communications Northwest Inc. deposited \$40 million in the escrow account established pursuant to the terms of the attached Escrow Agreement. A copy of the confirmation received from The Bank of New York Mellon, as Escrow Agent, is attached.
