On October 1, 2021, Avista Corporation, d/b/a/ Avista Utilities, (Avista) filed its Clean Energy Implementation Plan (CEIP) with the Washington Utilities and Transportation Commission (Commission) pursuant to WAC 480-100-640.

Interested persons may submit written comments on Avista's CEIP **no later than 5 p.m. Friday, January 28, 2022**. Pursuant to WAC 480-07-140(5), written comments must be submitted in electronic form, specifically in searchable .pdf format (Adobe Acrobat or comparable software). Those comments must be submitted via the Commission's web portal at <http://www.utc.wa.gov/e-filing>. If you are unable to submit documents via the portal, you may submit your comments by email to the Commission's Records Center at records@utc.wa.gov or by mailing or delivering an electronic copy to the Commission's Records Center on a flash drive, DVD, or compact disc that includes the filed document(s). Comment submissions should include:

- the docket number (Docket UE-210628),
- the commenter's name, and
- The title and date of the comment or comments.

The Commission will post on its web site all comments that are provided in electronic format.

If you are unable to file your comments electronically the Commission will accept a paper document.
