**NOTICE OF OPPORTUNITY TO COMMENT

TO ALL INTERESTED PERSONS:

The Commission Staff has completed a third discussion draft of the financial records and reporting rules in WAC Chapters 480-70 (Solid Waste and/or Refuse Collection Companies), 480-90 (Gas Companies), 480-92 (Low-Level Radioactive Waste), 480-100 (Electric Companies), 480-110 (Water Companies), and 480-120 (Telecommunications Companies). This revised draft reflects the previous round of written comments, and discussions we have had with stakeholders during the redrafting process. We wish to offer you another opportunity to comment before finalizing the draft for presentation to the Commission as part of a CR-102 on **Wednesday, June 30, 2004.**

**Interested persons may file written comments on this draft by Tuesday, May 18, 2004.** We are specifically interested in your comments concerning:

- The appropriateness of the thresholds
- Any specific burdens you think that the rules will cause and the financial impact of those specific burdens

We will take your comments into account when we finalize the CR-102 draft, which will be made available during the week of June 14, 2004. You will have an opportunity to comment orally to the Commission on June 30, 2004, when Staff presents the final CR-102 draft to the Commission.
