

This letter follows up on our telephone conversation regarding the upcoming hearing on the stipulation that parties have presented to the Washington Utilities and Transportation Commission ("WUTC") to resolve the issues in Docket No. UG-061721. Boise Cascade is an intervenor in this proceeding and a signatory to the stipulation. Boise Cascade takes gas transportation service from Cascade Natural Gas, and Boise Cascade intervened in this proceeding with limited interests in mind. As a result, Boise Cascade did not retain an expert witness to address the joint application in this proceeding, and Boise does not have a witness to provide sworn testimony at the hearing regarding policy issues related to the stipulation. I will attend the hearing for Boise Cascade and will be available to answer questions that the Commissioners may have.


