2. I am the Area Director of M&I Sales for Waste Management of Washington, Inc. ("WMW"). I have worked for WMW for approximately 13 years.
3. Once intermodal cargo containers of OCC Rejects from Port Townsend Paper or McKinley Paper Company arrive at the Olympic View Transfer Station, Waste Management Disposal Services of Oregon, Inc. loads the intermodal containers onto rail cars owned and operated by Union Pacific Railroad ("UPRR"). Intermodal cargo containers of OCC Rejects arriving at North Mason Fiber Co. are loaded by North Mason Fiber for further transportation,
