Dear Mr. King,

Enclosed are an original and three copies of the replacement pages to the Puget Sound Energy, Inc. ("PSE") 2013 Annual Report of Energy Efficiency Conservation Accomplishment (the "Annual Report"). Specifically, the replacements are of pages 1, 8 and 121 of the Annual Report, and a replacement of Exhibit 1: 2013 Savings and Expenditures.

Subsequent to PSE's February 13, 2014, filing of the Annual Report, PSE discovered that a cell within its Exhibit 1 workbook template that was referencing an incorrect value in the "Customer Online Experience" budget sub-total line. The tables on pages 1, 8, and 121 are all linked to this master table and also an incorrect budget amount in the "Customer Online Experience" sub-total for both electric and gas budget amounts shown on Exhibit 1.

Specifically, in Exhibit 1, the electric Customer Online Experience total indicated a budget amount of \$632,000, when it should indicate a budgeted amount of \$999,000. Similarly, the gas total budget amount for Customer Online Experience indicated an amount of \$95,000, when the actual budgeted total is \$150,000. These amounts are rounded. The corrected values reconcile with those originally filed in PSE's 2013 Annual Conservation Plan. The overall effects on budgeted amounts are:

PSE requests that these replacement pages be filed in Docket Nos. UE-970686 and UE-111881. The Conservation Resource Advisory Group (CRAG) received replacement electronic files and hard-copy replacement pages during PSE's CRAG meeting on March 6, 2014.
