BACKGROUND

- On December 13, 2018, Pacific Power & Light Company (Pacific Power or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective tariff, WN U-75 for Electric Service, as listed in the appendix attached to this Order. The purpose of this filing is to increase rates and charges for electric service provided to customers in the state of Washington.
- In its filing, Pacific Power proposes an increase in revenues of approximately \$3.1 million from Washington operations. The Company proposes, however, to offset this increase by the amortization of remaining deferred tax benefits associated with the Tax Cuts and Jobs Act (TCJA) of approximately \$7.1 million, resulting in an overall rate reduction of \$4.0 million, or approximately 1.1 percent.
- The Company agrees to waive presentation of its filing at an open meeting and to suspension of the tariffs pending Commission investigation. Pacific Power's proposed tariff schedules are dated March 1, 2020, and the Company requests a rate effective date of January 1, 2021.

DISCUSSION AND DECISION

Pacific Power's requested increase might injuriously affect the rights and interests of the public, and Pacific Power has not demonstrated that the increase would result in rates that are fair, just, reasonable, and sufficient. The Commission, therefore, suspends the tariff

filing and will hold public hearings, if necessary, to determine whether the proposed increases are fair, just, reasonable, and sufficient.

FINDINGS AND CONCLUSIONS

- The Commission is an agency of the State of Washington vested by statute with the authority to regulate rates, regulations, practices, accounts, securities, transfers of property, and affiliated interests of public service companies, including electric companies.
- 6 (2) Pacific Power is an electric company and a public service company subject to Commission jurisdiction.
- 7 (3) The tariff revisions Pacific Power filed on December 13, 2019, would increase charges and rates for service provided by Pacific Power and might injuriously affect the rights and interest of the public.
- 8 (4) Pacific Power has not yet demonstrated that the proposed tariff revisions would result in rates that are fair, just, reasonable, and sufficient.
- 9 (5) Pacific Power's rates and charges for electric service shown on any tariffs that Pacific Power does not propose to revise may also be investigated to determine if they are fair, just, reasonable, and sufficient.
- In order to carry out the duties imposed upon the Commission by law, and as authorized in RCW 80.04.130, the Commission finds it is necessary to investigate Pacific Power's books, accounts, practices and activities; to make a valuation or appraisal of Pacific Power's property; and to investigate and appraise various phases of Pacific Power's operations.
- The Commission finds that this docket meets the criteria of WAC 480-07-400(2)(b)(i) and that the parties may conduct discovery pursuant to the Commission's discovery rules in WAC 480-07-400 425.

12 (8) As required by RCW 80.04.130(4), Pacific Power bears the burden to prove that the proposed increases are fair, just, reasonable, and sufficient.

13 (9) Pacific Power may be required to pay the expenses reasonably attributable and allocable to such an investigation, consistent with Chapter 80.20 RCW.

ORDER

THE COMMISSION ORDERS:

- The tariff revisions Pacific Power & Light Company filed on December 13, 2019, 14 (1) are suspended.
- The Commission will hold hearings at such times and places as may be required. 15 (2) Such hearings may also examine Pacific Power & Light Company's rates and charges for electric service shown on any tariffs that Pacific Power & Light Company does not propose to revise.
- 16 (3) Pacific Power & Light Company must not change or alter the tariffs filed in these dockets during the suspension period, unless authorized by the Commission.
- The Commission will institute an investigation of Pacific Power & Light 17 (4) Company's books, accounts, practices, activities, property, and operations as described above.
- 18 (5) Discovery will be conducted pursuant to the Commission's discovery rules in WAC 480-07-400 – 425.

19 (6) Pacific Power & Light Company shall pay the expenses reasonably attributable and allocable to the Commission's investigation, consistent with Chapter 80.20 RCW.
