Dear Ms. Hunter:

On December 12, 2022, the Washington Utilities and Transportation Commission (Commission) entered Order 10/04 in Dockets UE-220053, UG-220054, and UE-210854 (consolidated), Final Order Rejecting Tariff Sheets; Granting Petition; Approving and Adopting Full Multiparty Settlement Stipulation Subject to Conditions; Authorizing and Requiring Compliance Filing (Order 10/04). Order 10/04, among other things, rejected the initial tariff proposals by Avista and required Avista to make a compliance filing by December 14, 2022, consistent with the Order.

On October 27, 2023, in compliance with Order 10/04, Avista filed revised tariff sheets for electric Tariff WN U-28 and natural gas Tariff WN U-29. The revisions to Tariff WN U-28 reflect the \$12.5 million increase in electric base revenue, offset by the Residual Tax Customer Credit, as ordered by the Commission. The revisions to Tariff WN U-29 reflect the \$1.5 million increase in natural gas base revenue, offset by the Residual Tax Customer Credit, as ordered by the Commission.

Commission staff (Staff) has reviewed the Company's compliance filing. Staff believes that the revised tariff revisions comply with Order 10/04, entered December 12, 2022. The tariff sheets indicated on the attachment to this letter will become effective December 21, 2023.
