#### **AMENDMENT NO. 18**

This Amendment No. 18 (the "Amendment") is made and entered into by and between Verizon Corporate Services Group Inc. f/k/a Verizon Services Corp. ("Customer") and Cellco Partnership, doing business as Verizon Wireless ("Verizon Wireless"), for attachment to that certain Agreement for the Purchases of Services (Contract No. BA 17132), executed on February 3, 1999, as amended, (the "Agreement").

- 1. This Amendment is an integral part of and modifies the Agreement. Terms used herein that are defined or specified in the Agreement shall have the meanings set forth in the Agreement. If there are any inconsistencies between the provisions of this Amendment and the provisions of the Agreement, the provisions of this Amendment shall control.
- 2. The term of the Agreement shall be extended for three (3) years from the Effective Date of this Amendment. Customer shall have two (2) one-year renewal options. To exercise such an option, Customer shall provide Verizon Wireless with a written request to renew at least thirty (30) days prior to the expiration of the Term or extended Term.
- 3. Sub-Section 56.1.2 of the Agreement as amended in Amendment 14 is hereby deleted from the Agreement in its entirety and replaced with a new sub-section 56.1.2, which reads as follows:
  - An early termination fee of \$175.00 applies for Corporate and Employee Subscriber lines in service for "56.1.2. less than the required twelve (12) or twenty-four (24) month line term at the time of termination. On an annual basis, however, Verizon Wireless shall waive the early termination fees for up to ten thousand (10,000) of Customer's Corporate Subscriber lines that are terminated prior to completing their applicable line terms, provided that Customer maintains a minimum of one hundred thousand (100,000) Corporate and Employee Subscribers. Verizon Wireless will review the number of Customer's Corporate Subscriber lines in service after the expiration of the first one hundred eighty (180) days following the Effective Date of this Amendment and on each one-year anniversary of the Effective Date of this Amendment, to adjust the early termination fee waiver allowance to an amount equal ten percent (10%) of the number of Customer's then-current Corporate Subscriber lines in service. Customer acknowledges that porting out a mobile telephone number from Verizon Wireless to another wireless service provider before the end of the applicable line term shall constitute a termination subject to an early termination fee. For each line activated or line term extended under the Agreement as amended, the early termination fee will be reduced by \$5.00 for each full month of service completed toward fulfillment of such line term.
- 4. All references in the Agreement as amended to Cellular Digital Packet Data Service shall be deleted and of no further force and effect.
- 5. All references in the Agreement as amended to Paging Services and Equipment shall be deleted and are of no further force and effect.
- 6. Except for the Telemetry Pricing added to the Agreement by Exhibit B-14 of Amendment 12, all existing Monthly Access Fee Discount Schedules, Calling Plans, Calling Plan Terms and Conditions and Corporate Equipment Pricing Matrix are deleted and replaced by the attached Exhibit A.
- 7. This Amendment No. 18 shall be effective when executed by both Parties.
- 8. All provisions of the Agreement, including attachments thereto, not addressed by this Amendment remain in full force and effect.
