- On May 29, 2003, Northland Investments LLC, d/b/a Call and Haul, filed an application (No. GA-079176) for a certificate of public convenience and necessity to operate motor vehicles in furnishing solid waste collection service consisting of yard waste and construction and demolition debris in Spokane County. Notice of the Application was published in the Commission's weekly Docket of September 2, 2003.
- The issues in this proceeding include whether the issuance of a certificate to Northland Investments LLC for the service it proposes is necessary and is otherwise consistent with the public interest, and whether other carriers are authorized to serve in the territory requested. The Commission has jurisdiction over this matter under Title 81 RCW, which authorizes it to regulate persons seeking to furnish solid waste collection services under chapters 81.77 RCW and 480-70 WAC.
- The statutes involved include those within chapter 81.04 RCW, chapter 81.28 RCW and chapter 81.77 RCW, including but not limited to RCW 81.77.040 and chapter 34.05 RCW. Rules involved include those within chapters 480-70 WAC and 480-09 WAC.
- The Commission sets a prehearing conference to discuss preliminary matters, the hearing process, and to formulate the issues. It is expected that the applicant will advise the Commission at the prehearing conference whether he has retained an

attorney. If applicant has retained an attorney, applicant will provide information about the attorney's schedule so that an evidentiary hearing in this case can be scheduled within 30 – 60 days of the prehearing conference. If applicant has not retained an attorney but wishes to proceed with the application, an evidentiary hearing will be scheduled for a date within 30 days of the prehearing conference.
