On August 11, 2004, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to review fee methodology established in WAC 480-93-240 and WAC 480-75-240 and to evaluate alternative methods for allocating pipeline safety program costs to pipeline operators regulated by the Commission. The CR-101, as filed with the Code Reviser, is available for inspection on the Commission's web site at www.wutc.wa.gov/041344. While interested parties were provided the opportunity to comment at this point, the one official comment received indicated that the commentor would reserve comment until a draft proposal has been offered. Since then, the commission has retained a consultant who has reviewed current law, past practices, cost data and previously-stated stakeholder concerns.
