# NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS ON CR-101 AND DISCUSSION DRAFT (By Wednesday, December 21, 2005)

RE: Rulemaking to Consider Amending WAC chapters 480-31 and 480-70, Relating to Notice and Opportunity for Hearing Prior to Suspension or Revocation of a Certificate, Docket No. T-051359

### TO INTERESTED PERSONS:

On October 5, 2005, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) at WSR # 05-20-093 to consider amending sections of WAC chapters 480-31, 480-51, and 480-70 to reflect recent changes to chapters 81.66, 81.77, and 81.84 RCW, relating to notice and opportunity for hearing prior to suspension or revocation of a certificate, and in conjunction with a request for certification to operate in a territory served by an existing certificate holder.

On November 23, 2005, the Commission filed a supplemental CR-101 to that noticed at WSR # 05-20-093 to consider adding new language or sections to implement the statutory amendments and remove chapter 480-51 WAC, Commercial Ferries, from this inquiry.
