Subject: CONTRACT NO. 1333ICB (Docket No. UT-060023)

Verizon Northwest Inc. submits Contract No. 1333ICB, a renewal of a customer specific agreement for 2-1-1 Routing Service filed under Amendment No. 2. The purpose of this Amendment is to extend the term of the agreement on a month-to-month basis for thirty-six (36) months. The customer is currently receiving this service under Contract No. 1316ICB, effective February 5, 2006 in Docket No. UT-060023 and Contract No. 1317ICB, Amendment No. 1, effective February 22, 2006 in the same docket.

2-1-1 Routing Service utilizes a three digit local dialing arrangement to permit voice access to non-emergency and social service agencies. The service will be provided using an Advanced Intelligent Network (AIN) solution, which Verizon companies are employing across the country, uses the most current switch technology, and provides the most accuracy in call completion.

The Company is utilizing a contract because this service is not offered under tariff, and there is limited demand for the service.

The pricing in this contract is the same as in Contract No. 1259ICB for 5-1-1 Routing Service, approved by the Commission in UT-031039. Therefore, no new cost support is being filed. Please refer to the cost support filed in that prior matter. The rates are not the Company's preferred pricing but are, in agreement with Commission Staff, comparable to Qwest's current



Nonrecurring Charges

The Nonrecurring Charges associated with this agreement are as follows: 2-1-1 Routing Service Establishment Charge of \$199.00 which will apply per point-to number in addition to the Central Office Switch Activation Charge per central office translated to the point-to number. The Service Establishment Charge will apply for any change to the point-to number after the initial deployment. The Service Establishment charge is intended to address the one-time service development and the initial provisioning of AIN. There is also a nonrecurring Central Office Switch Activation Charge per Central Office Switch translated of \$22.25.

Since the Company and Staff have agreed to the terms for providing this service, no cost support documentation is included with this filing. Cost support documentation for 5-1-1 Service was filed under Contract No. 1259ICB, effective July 10, 2003 in Docket No. UT-031039. Verizon agrees to provide 2-1-1 service under this contract (not to set a precedent) to Washington Information Network 2-1-1 at rates comparable to Qwest's current tariff rates and no monthly recurring charges for 2-1-1 service in Washington.
