TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in the Washington Utilities and Transportation Commission's (Commission) rulemaking in Docket TV-090400. In this rulemaking, the Commission is proposing to amend WAC 480-14, Motor Carriers. This letter also provides notice of an opportunity to file written comments on the proposed rules and participate in the formal rule adoption hearing.

Please note: The changes recommended in these rules will not affect motor carriers' day-to-day operations. These are strictly housekeeping changes to existing rules.

WAC 480-14 contains rules for motor carriers of property other than household goods carriers. The rules cover intrastate common carriers and armored car service carriers, as well as interstate common carriers. The rules set out requirements for permits and registrations, liability insurance and safety.

In 1995, the state Legislature transferred all safety regulation for motor carriers of property other than household goods to the State Patrol. Because the State Patrol did not have its own safety rules for motor carriers at that time, it continued to enforce the Commission's safety rules in WAC 480-14. The State Patrol completed its final safety rules this year; therefore, many rules in WAC 480-14 are no longer necessary.

On May 6, 2009, the Commission filed an expedited rulemaking (CR-105) in this docket with the Code Reviser setting a deadline of July 6, 2009, for interested persons to submit written comments on the proposed rules. The Commission received written comments from two individuals. Under the expedited rulemaking statute, RCW 34.05.353, if a written notice of objection to the expedited rulemaking is timely filed and is not withdrawn, the notice of proposed expedited rulemaking is considered a statement of inquiry (CR-101). That means that this rulemaking cannot proceed on an expedited basis. The Commission will therefore proceed to consider this docket according to the standard rulemaking process (CR-102). A summary/matrix of the comments received is posted to the UTC's web site at www.utc.wa.gov/090400.

On September 2, 2009, the Commission filed a CR-102 in this docket with the Code Reviser. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

THE COMMISSION GIVES NOTICE of your opportunity to submit written comments on the proposed rules by filing with the Commission Executive Director and Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. The proposed rules, as filed with the Code Reviser, are available for inspection on the Commission's web site at www.utc.wa.gov/090400. The Commission will send you a paper copy of the proposed rules or will send the proposal via electronic mail, if you ask.
