- On December 4, 2009, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TV-091445 against Irvington Transfer and Storage d/b/a ITS Global Relocation Services (ITS Global) in the amount of \$900, alleging one or more violations of WAC 480-15-630, which specifies how household goods moving companies may issue supplemental estimates, and seven violations of provisions of Tariff 15-C, which identifies the rates and charges household goods companies may charge their customers, as well as the items a company must include on its estimate forms and bills of lading.
- 2 On December 15, 2009, ITS Global filed with the Commission a request for hearing stating that some of the alleged violations did occur, and that some of the alleged violations did not occur.
- 3 On December 17, 2009, Commission Staff filed a Response stating that it does not oppose ITS Global's Request for Hearing.
- ⁴ Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the penalty should be mitigated and what actions are necessary for ITS Global to maintain future compliance, pursuant to statutory provisions of RCW 81.04.

- 5 THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 1:30 p.m., on Thursday, January 28, 2010, in Room 108, First Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
- 6 The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- 7 Written notice of any other stage in the proceeding or other formal proceedings that the Commission may deem appropriate will be given during the course of this case. The Commission will provide at its offices in Olympia, Washington, copies of documents in the current record for use by the parties or others who may want to review them.
- Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a list enumerating and describing any such documents no later than 5:00 p.m. on Thursday, January 21, 2010, and bring an original and three (3) copies to the hearing. Filing shall be in accordance with WAC 480-07-140 and 145.
- 9 THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.
