**SCHEDULE 95A**  
**PRODUCTION TAX CREDIT TRACKER**

**APPLICABILITY:**

1. This Production Tax Credit Tracker rate shall be applicable to the electric energy delivered to Customers under any schedule contained in this tariff except those Customers served on Schedules 448 and 449. This Production Tax Credit Tracker rate shall be applicable to the electric energy delivered to Customers under any special contract unless specifically excluded by such special contract.
2. The rates in this schedule shall be adjusted so that the amount of the production tax credit that is available to the Company for generating electricity from wind is passed through to Customers, as such credit becomes available irrespective of when the Company applies for tax recovery of the credit amount.

**PURPOSE:**

1. To pass the benefits of the production tax credit to Customers as it is generated. The credit is available for a ten-year period and will expire on December 31, 2015. The Company may adjust the credit annually based on the differences between the credits provided to Customers and the credits actually earned due to wind generation, plus the estimated credits for the next year, less the interest associated with the deferred tax balance for the credits. If the difference is estimated to be greater than twenty five percent (25%), the Company may file to update the credit more often than annually.
