Description of amendment: This Agreement amends the reciprocal compensation rates in the Agreement set forth in Table 1 to this amendment.

The amendment amends the interconnection agreement accepted by the Commission on October 29, 2009 in WUTC Docket No. UT-093036.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. 

- (3) The laws and regulations of the State of Washington and Commission Orders govern the construction and interpretation of the Amended Agreement. The Amended Agreement is subject to the jurisdiction of the Commission.

The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
