Company proposes to change Tariff Number 25

The company requests Commission approval to amend its filed Tariff Number 25 on Less Than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$2.4910 per gallon for the base period to \$3.7317 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 26 in the amount of 1.34%.

3. The temporary 1.34% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of November 2012 and December 2012, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of February 2013 and March 2013.
