Fuel index prices have increased from \$2.9480 per gallon for the base period to \$3.8441 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 18 in the amount of .62%.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: July 1, 2013.
2. The proposed changes will expire on: September 30, 2013.
3. The temporary .62% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of April 2013 and May 2013, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of July 2013 and August 2013.
