5	JUDGE TOREM: Good morning. We will be
6	on the record.
7	My name is Adam Torem. I am an administrative
8	law judge with the Washington Utilities and
9	Transportation Commission. I am the presiding officer
LO	for today's hearing that is being conducted at the
L1	Commission's headquarters in Olympia. Today is
L2	Tuesday, May 6th, 2014. It is now almost 9:40 in the
L3	morning. We started a little late to accommodate some
L4	long travel for some of the respondents this morning.
L5	Today's hearing is supposed to involve a total
L6	of nine household goods carriers. The first order of
L7	business that I am going to do is take a roll call,
L8	determine which companies that were served and
L9	subpoenaed have actually responded and appeared here
20	in Olympia. I am just going to ask you to identify
21	yourself. I think I have the names of each
22	representative to go with the company.
23	As you can see, there is a court reporter
24	here, down to my left, your right, taking down a
25	record of today's proceedings. I will repeat your

- 1 name for now. When you come up later to address the
- 2 court, you will come up to the tables in front of me.
- 3 There is a set of microphones, and I will tell you how
- 4 those work a little bit later.
- 5 Right now I am just going to call a docket
- 6 number assigned with your case and figure out who is
- 7 here and then I will tell you the rest of the
- 8 procedures.
- 9 The first docket is TV-140338, Movers Plus. I
- 10 think it is Joshua Washburn. Is there a Mr. Washburn
- 11 present? All right.
- 12 Docket TV-140339, this is Queen City Movers,
- 13 LLC, Jonathan Jorde.
- MR. JORDE: Right here, Your Honor.
- JUDGE TOREM: Thank you for appearing.
- MR. JORDE: Thank you.
- JUDGE TOREM: Docket TV-140340, Sea-Tac
- 18 Movers, LLC, Doyin Adekanmbi.
- MR. ADEKANMBI: Here, Your Honor.
- JUDGE TOREM: Thank you, sir.
- MR. ADEKANMBI: Uh-huh.
- JUDGE TOREM: Docket TV-140341, Man of
- 23 Steel Movers, Michael Pandolfi. Mr. Pandolfi? Not
- 24 yet.
- Docket TV-140342, All City Movers. Is it

- 1 Ms. Darcy Allen?
- MS. ALLEN: Yes.
- JUDGE TOREM: TV-140343, Precision
- 4 Moving Seattle, Christopher Dems. Mr. Dems?
- 5 Docket TV-140344, this is Steven Ronald
- 6 Erickson.
- 7 MR. PLOWMAN: Present with counsel.
- 8 JUDGE TOREM: All right. Counsel, when
- 9 I call the case forward I will have you make a formal
- 10 appearance.
- MR. PLOWMAN: Thank you.
- JUDGE TOREM: TV-140345, Cope Quality
- 13 Services, Ms. Carrie Kreech.
- 14 And Docket TV-140435, Pro Moving Delivery,
- 15 LLC, Alexander Satir.
- MR. ALEXANDER SATIR: (Indicating.)
- JUDGE TOREM: How do you say the last
- 18 name, sir?
- 19 MR. ALEXANDER SATIR: "Satir."
- JUDGE TOREM: All right, thank you.
- 21 So five of the companies out of the nine that
- 22 were served are here today. We are still waiting to
- 23 hear from four of them. Those companies that have not
- 24 appeared and may not appear this morning are subject
- 25 to being held in default and having an order entered

- 1 against them without a chance to speak their piece
- 2 before the Commission. We will address those later
- 3 this morning.
- 4 For the five of you that did come down to
- 5 Olympia today, thank you very much for coming down.
- 6 You are here because over the last several weeks the
- 7 Commission filed a complaint against your company or
- 8 you individually, alleging that your company is
- 9 performing or advertising to perform work as a
- 10 household goods carrier without the required permit.
- 11 As you probably now know, under Washington law it is
- 12 strictly prohibited to engage in business as a
- 13 household goods carrier without first obtaining a
- 14 household goods permit from the Utilities and
- 15 Transportation Commission. The law that is cited in
- 16 your compliant that was filed against you is in the
- 17 Revised Code of Washington, Title 81, Chapter 80, and
- 18 it is Section 75, Sub 1, so RCW 81.80.075(1).
- 19 The purpose of this mover's court proceeding
- 20 today is to formally explain your choices under the
- 21 law and then give you a chance to work with Commission
- 22 Staff about the options you want to pursue. In
- essence, today you have to choose between two paths on
- 24 behalf of your company. You can choose to cease and
- 25 desist offering household goods moving services until

- 1 you get a permit, or you can ask for a formal
- 2 classification hearing and tell us that the Commission
- 3 somehow has this wrong, that you are not really doing
- 4 household goods moving services and you shouldn't be
- 5 classified that way.
- 6 That's not something I can settle today, it
- 7 will require a formal hearing where you present
- 8 evidence and the Commission presents evidence and
- 9 either myself or another administrative law judge
- 10 issues a written ruling, deciding -- if you are not a
- 11 household goods carrier, the complaint is dismissed;
- 12 if you are a household goods carrier, we are back to
- where we are this morning, you either have to get a
- 14 permit or you are subject to a fine and you have to
- 15 cease and desist.
- Most companies -- we have been doing this for
- 17 a couple years -- come in to the Commission and choose
- 18 that they are not going to continue to work without a
- 19 permit. If you choose to do that this morning, you
- 20 will need to demonstrate what you are doing to shut
- 21 down your business in whole or in part, to make sure
- the Commission doesn't have to take further
- 23 enforcement action.
- 24 The idea of you coming down here to Olympia
- 25 today is to resolve this once and for all. I don't

- want to see you back at a second mover's court or on
- 2 another docket because you have told me one thing
- 3 today and we find out you are still doing moves
- 4 illegally later. The Commission wants to see, and I
- 5 want to hear sufficient proof that you really are
- 6 getting out of the business or you have stopped your
- 7 business until you can obtain a permit. In other
- 8 words, you have got to give me sufficient assurance
- 9 that you are no longer going to engage in unlawful
- 10 household goods moving services.
- Now, each of you has a right to be heard by
- 12 the Commission. We don't make it a practice to
- 13 prejudge your case. Each one of you has got a
- 14 different story, but it is the same industry. There
- 15 are certain patterns we have observed here. The
- 16 requirement that can't go away, one that is required
- by law, is you need a permit if you want to give
- 18 household goods moving services within the state of
- 19 Washington.
- Now, you have a right to be heard and so does
- 21 Commission Staff. Today Ms. Lynda Holloway, seated to
- 22 my right, is going to be representing Commission
- 23 Staff. She is a compliance investigator with the
- 24 Utilities and Transportation Commission. If you
- 25 haven't met Ms. Holloway already, you will be talking

- 1 to her at some point later today. Those are the two
- 2 general options: The cease and desist option or ask
- 3 for a formal classification hearing.
- In a few minutes, I'm going to call each of
- 5 your companies up to the microphone, you can tell me
- 6 how you want to proceed. I will swear you in with an
- 7 oath of witness so that you can testify and the
- 8 court reporter can take down the truth, the whole
- 9 truth, and all of that nothing but the truth stuff you
- 10 are used to hearing on TV. It is your opportunity to
- 11 play that role at this table. Please take it
- 12 seriously. Again, it makes her job much easier as the
- 13 court reporter if only one of us speaks at a time and
- if you speak slowly and clearly.
- 15 Once you are sworn in, I am going to ask you
- 16 if you understand your options and then you can state
- 17 your preference. If there is something else you need
- 18 to explain to me you can do so at that time.
- 19 Now, in each of the complaints that you were
- 20 served, if you have that paperwork with you,
- 21 Commission Staff has not only alleged you are
- 22 providing household goods services without a permit,
- 23 but they are also seeking to have a penalty imposed.
- 24 The law sets a maximum penalty for each violation at
- 25 \$5,000. Ms. Holloway, on behalf of Staff, is going to

- 1 be making a recommendation as to what penalty, if any,
- 2 should be imposed on your company. I will make a
- final decision based on what she tells me about your
- 4 case and what you tell me about your company and the
- 5 individual circumstances. There are a number of
- factors to be considered and you can ask to be heard
- 7 on the issue of penalty as well, as to what your
- 8 intentions are with regard to the company.
- 9 I think that's most of what I wanted to tell
- 10 you.
- 11 Now, after I hear from the five companies that
- 12 are here this morning, we will probably take a break.
- 13 For those of you that want to draft up an agreed cease
- 14 and desist order, there is some additional Commission
- 15 Staff seated at the back table to the right. They
- will be working with some of you and helping you
- 17 understand an order that would entered in the case, if
- 18 you are choosing to agree to cease and desist until
- 19 you get a permit.
- 20 For those of you that might want a full
- 21 hearing on the matter, we will just be setting a
- 22 schedule for that and going ahead and setting -- I
- 23 will send you out a prehearing conference order to set
- 24 up the matter for when it will be heard and tell you
- what date you have got to file your exhibits.

- 1 Ms. Holloway, I am going to swear you in shortly. Do you want to make any general comments now 2 on behalf of Staff before we call the individual 4 cases? 5 MS. HOLLOWAY: No. JUDGE TOREM: All right. Let me swear 6 7 you in, so you are sworn in for the entire proceeding. 8 witness herein, having been 9 LYNDA HOLLOWAY, 10 first duly sworn on oath, was examined and testified as follows: 11 12 13 JUDGE TOREM: So let me start with those companies who have made an appearance today. Again, 14 15 this is just an opportunity for you to decide how you 16 want to proceed. Let's start with Mr. Jorde. 17 18 MR. JORDE: Yes, sir.
- JUDGE TOREM: If you will come up for
- 20 Queen City Movers. This is again, Docket TV-140339.
- 21 If you will have a seat, please.
- MR. JORDE: (Complies.)
- JUDGE TOREM: If you can pull that
- 24 microphone close to you.
- MR. JORDE: Yes, Your Honor.

that correct?

- 1 JUDGE TOREM: There is a little silver 2 button in the middle. If you push on that, a red light should come on. 4 MR. JORDE: Yes, Your Honor. 5 JUDGE TOREM: Now you have got the amplification. 6 7 Mr. Jorde, do you understand everything that I explained earlier? 8 MR. JORDE: Yes, Your Honor. 9 10 JUDGE TOREM: Let me swear you in. 11 12 JONATHAN JORDE, witness herein, having been 13 first duly sworn on oath, was examined and testified as follows: 14 15 16 JUDGE TOREM: Mr. Jorde, do you have any 17 questions before we get --18 MR. JORDE: No, Your Honor. 19 JUDGE TOREM: Your case again was 20 140339. 21 Ms. Holloway, in this case the complaint said 22 that he had offered a move, as well as advertised; is
- JUDGE TOREM: And have you had a chance

MS. HOLLOWAY: Yes, that's correct.

- 1 to talk with Mr. Jorde since the complaint was served
- 2 about the evidence or about the Commission's intent
- 3 here?
- 4 MS. HOLLOWAY: Yes, we did have a
- 5 conversation. He has already applied for his
- 6 household goods permit.
- 7 JUDGE TOREM: Mr. Jorde, is that
- 8 correct?
- 9 MR. JORDE: Yes, Your Honor.
- 10 JUDGE TOREM: You understand you can't
- 11 continue to offer moves until you get a permit,
- 12 though, right?
- MR. JORDE: Yes, Your Honor.
- JUDGE TOREM: So how do you want to
- 15 proceed this morning?
- MR. JORDE: Well, I can show you
- 17 evidence that I have basically shut down my
- 18 advertising, which is -- you know, basically was a
- 19 website and a Yelp page. Any calls that have been
- 20 fielded to me, I just told them that I'm not operating
- 21 as a mover and I recommended other movers that had
- 22 permits, Your Honor.
- JUDGE TOREM: Was it your own website?
- MR. JORDE: Yes, Your Honor.
- JUDGE TOREM: What did you do about the

- 1 Yelp page?
- 2 MR. JORDE: I contacted Yelp and had
- 3 them -- it says on the Yelp page, This business is
- 4 closed. I can show you that on my phone, if you would
- 5 like to see it, Your Honor.
- 5 JUDGE TOREM: Ms. Holloway, have you had
- 7 a chance to verify those efforts?
- 8 MS. HOLLOWAY: No, I haven't.
- 9 JUDGE TOREM: I will leave that for
- 10 Staff to verify. It may be able to be done at the
- 11 break.
- MR. JORDE: Yes, Your Honor.
- 13 JUDGE TOREM: You want to pursue a cease
- 14 and desist order; is that correct? Essentially until
- you get a permit, you are not going to operate?
- MR. JORDE: Yes, Your Honor.
- 17 JUDGE TOREM: Staff, any recommendations
- 18 that you want to make regarding a cease and desist
- 19 order for Mr. Jorde?
- MS. HOLLOWAY: Staff supports a cease
- 21 and desist order for Mr. Jorde.
- JUDGE TOREM: And some of you will
- 23 follow this path Mr. Jorde has followed. What I am
- 24 going to recommend is that you step out with Staff.
- 25 Someone will verify, if you can tell them what the

- 1 websites were, I think it's part of the evidence
- 2 packet here, confirm what you are saying. They can
- 3 come back, and based on if they can confirm that, they
- 4 will make a recommendation. If there is going to be a
- 5 penalty, if any in your case, we will deal with that
- 6 when we come back.
- 7 The order has citations, essentially, where
- 8 you say, yeah, I was operating without a permit, I had
- 9 these advertisements, but I'm not going to do it until
- 10 I get a permit. Once you are satisfied you understand
- 11 all the language in the order, you will sign it,
- 12 Ms. Holloway will sign it. Hopefully, it is an agreed
- 13 recommendation as to penalty, if there is any, and if
- 14 not, you can make your case as to why the penalty
- should be, I would imagine, less than what Commission
- 16 Staff is recommending.
- MR. JORDE: Yes, Your Honor.
- 18 JUDGE TOREM: Ms. Holloway, any other
- 19 questions on this case?
- MS. HOLLOWAY: No.
- JUDGE TOREM: Thank you, Mr. Jorde. You
- 22 will step back and we will call the next case.
- MR. JORDE: (Complies.)
- JUDGE TOREM: This will be Docket
- 25 TV-140340, Sea-Tac Movers, LLC, Mr. Adekanmbi. You

25

1 can take a seat there -- actually, before you sit down let me swear you in. 2 4 DOYIN ADEKANMBI, witness herein, having been 5 first duly sworn on oath, was examined and testified as follows: б 8 JUDGE TOREM: How do I pronounce your 9 last name, sir? 10 MR. ADEKANMBI: "Adekanmbi." 11 JUDGE TOREM: I got it right. 12 MR. ADEKANMBI: Yes, you did. 13 JUDGE TOREM: Excellent. I looked at it yesterday and I thought, I practiced it a few times, I 14 might pull it off. 15 16 MR. ADEKANMBI: I get that a lot. 17 JUDGE TOREM: All right. Mr. Adekanmbi, 18 your company is called Sea-Tac Movers, LLC? 19 MR. ADEKANMBI: Yes, sir. 20 JUDGE TOREM: And have you had a chance 21 to talk with Ms. Holloway or Commission Staff? 22 MR. ADEKANMBI: We have talked a bunch, yeah. She's been very helpful. 23

you are here today. How do you want to proceed?

JUDGE TOREM: Good. You understand why

- 1 MR. ADEKANMBI: If you don't mind, Your
- 2 Honor, I have a few questions.
- JUDGE TOREM: Please.
- 4 MR. ADEKANMBI: I was a little confused
- 5 because I remember talking to Ms. Holloway --
- 6 Mrs. or Ms.?
- 7 MS. HOLLOWAY: You can just call me
- 8 Ms. Holloway.
- 9 MR. ADEKANMBI: -- Ms. Holloway from the
- 10 beginning. She has worked with me through the process
- 11 from when I moved to Washington. We are based out of
- 12 Baltimore, Maryland, and Charlotte, North Carolina,
- and this is hopefully the next hub. She -- I guess
- 14 the first ad she saw on Craigslist, which is where
- 15 we -- our conversation started, and she brought it to
- 16 my attention that you can't -- you can't do this. I
- 17 worked with her over time.
- 18 My understanding was that as long as I wasn't
- 19 advertising using a truck, that I wasn't considered a
- 20 household goods mover. Which I think I still verified
- 21 with her last week, after I got subpoenaed. And all
- 22 the ads over the months have lapsed. We had a
- 23 provider that was automatically updating all our ads.
- 24 When she brought that to my attention -- I know it
- 25 took a couple weeks, but we finally got to the point

- 1 where all the ads that had paid for ran out and
- 2 lapsed. We don't advertise trucks. We, in bold caps,
- 3 let people know that they have to get the U-Haul and,
- 4 you know, how much it is. So we haven't advertised.
- 5 And then after I got served I was curious and
- 6 I asked her why. You know, she said on our website it
- 7 still says that we offer the truck services. I'm not
- 8 sure if I mentioned it to her, the website is designed
- 9 because where -- it's not for Washington, the website
- 10 is for all the states that we service, and I explained
- 11 that to her. We are not offering truck services here
- 12 in Washington. Even Craigs -- are up -- were up a
- 13 couple weeks ago say that we do not offer, you know,
- but you can rent a U-Haul and we will provide the
- 15 labor for you. We say labor only, labor-only rates.
- So I was a little confused about that because
- 17 we are not offering that. I'm not sure exactly how I
- 18 was violating that, but she said because of the
- 19 website. As of the subpoena, I requested Go Daddy,
- 20 who is my host, to take down the site. To be honest
- 21 with you, I am not sure that has happened. They said
- once you pay for it, it's...
- But no, we are not offering truck services. I
- 24 was hoping to get some more clarification and to let
- 25 the Court know that I do not advertise that I have a

- 1 truck or that I am moving people with trucks and I
- 2 don't plan to.
- JUDGE TOREM: We will hear from Staff in
- 4 a minute. What I hear you saying, Mr. Adekanmbi, is
- 5 you are trying to comply with the law and offer only
- 6 what is called pack-and-load services?
- 7 MR. ADEKANMBI: Yes, sir.
- JUDGE TOREM: The Commission does not
- 9 govern pack-and-load operators, but it is a slippery
- 10 slope: The truck, who rents the truck and who
- 11 operates the truck. It is a careful place that you
- 12 have to be. I haven't looked at your website or the
- 13 evidence in your case yet. Today is a scheduling
- 14 determination mainly.
- 15 If Ms. Holloway is convinced the claim should
- 16 be withdrawn, she will let me know, and we will hear
- 17 from her shortly. It sounds to me like you are saying
- 18 you are not a mover. Unless I am misunderstanding,
- 19 you want to set up a hearing as to what services you
- are really offering and we will do that another day.
- 21 MR. ADEKANMBI: If that's the next step,
- 22 yes, Your Honor.
- JUDGE TOREM: That's one choice.
- 24 The second choice, again, is that cease and
- desist, where you agree that you at some point made a

- 1 mistake and did advertise in a way that could be
- 2 interpreted as offering moving services.
- MR. ADEKANMBI: That's correct, Your
- 4 Honor.
- 5 JUDGE TOREM: If you acknowledge that,
- 6 that you are not doing it anymore, then I would
- 7 recommend -- it's easier to be here today, agree that
- 8 you are not offering the truck anymore, get what Staff
- 9 calls technical assistance --
- 10 MR. ADEKANMBI: Okay.
- 11 JUDGE TOREM: -- to make sure that your
- website complies with Washington law and can't be
- interpreted by not just the experts at the Commission,
- but anybody that looked in the Yellow Pages, anybody
- that looked in Craigslist or Go Daddy's website would
- know we do not do point-to-point moves in Washington.
- 17 We will help you pack your truck, we will help you
- 18 unload your truck, we do nothing else. If that's what
- 19 the website says to the layperson on the street, and
- that's the service they want, and they are not getting
- 21 anything more, Commission Staff can read that and
- 22 determine that's not a household goods permit-required
- 23 activity.
- MR. ADEKANMBI: Okay.
- JUDGE TOREM: If they come back later,

- 1 make a phone call and ask you to drive a truck and you
- 2 say yes, you will be back here.
- 3 MR. ADEKANMBI: I'm happy to comply,
- 4 Your Honor.
- 5 JUDGE TOREM: I hope so. You are
- 6 presenting yourself well this morning. I just want to
- 7 make sure you understand. If you agree to cease and
- 8 desist and they find you as a, I hate to say repeat
- 9 offender down the road, but that's the analogy, then
- 10 the Commission will level that full \$5,000 penalty.
- 11 That's not a situation that's good for anybody's
- 12 business. Our goal generally is to have people
- 13 understand law and then comply with the law.
- Ms. Holloway, what is the Commission's
- position for this case, for Sea-Tac Movers?
- 16 MS. HOLLOWAY: The Commission would like
- to see a cease and desist order and possible
- 18 suspension of part of the penalty.
- 19 The investigation in this case started with,
- 20 actually with Ms. Lauren McCloy last year, and then I
- 21 took over the case after the first of the year. As he
- 22 said, we have had several conversations. In one of
- them, using an assumed name, asking for a move from
- 24 Everett to Kent, he offered \$120 per day to provide a
- 25 truck in that move.

- 1 JUDGE TOREM: How long ago was that
- 2 discussion?
- 3 MS. HOLLOWAY: That was in February. We
- 4 have had other discussions since then. That was
- 5 before the mover's court documents were written.
- 6 JUDGE TOREM: So in the sequence of
- 7 events, Mr. Adekanmbi describes the Commission had
- 8 evidence they thought of a move being offered without
- 9 a permit.
- MS. HOLLOWAY: Yes.
- 11 JUDGE TOREM: And since that time the
- 12 subpoena has been issued, you have been working with
- 13 Mr. Adekanmbi to understand the law?
- MS. HOLLOWAY: No, I have been working
- 15 with him more in the context of having the process
- 16 server serve him.
- 17 JUDGE TOREM: Mr. Adekanmbi, the Staff's
- 18 position is that you take the cease and desist
- 19 approach. If you do that, my caution to you is that
- 20 you be sure you are out of the business, that you are
- 21 ceasing offering any moves with a truck, when you sign
- the order saying, yeah, that's what I want to do, I am
- 23 truly getting out of the business.
- 24 If you decide -- if you say you have this
- 25 moving company in Baltimore and on the East Coast and

25

how are you today?

1 you want to offer moves here in Washington, apply for 2 the permit first, then change your advertising once the permit, at least a temporary permit is issued. 4 That keeps you on the bright side line of the law. Is 5 that what you want to do today? MR. ADEKANMBI: Yes, Your Honor. б 7 JUDGE TOREM: So I'm going to ask you to step back and Staff will come and get you when we take 8 our break. 9 10 MR. ADEKANMBI: Thank you. JUDGE TOREM: Make sure you understand 11 12 the order. 13 The next case is 140342, All City Movers, Ms. Darcy Allen. 14 15 Raise your right hand. 16 MS. ALLEN: (Complies.) 17 18 DARCY ALLEN, witness herein, having been 19 first duly sworn on oath, was examined and testified as follows: 20 21 22 JUDGE TOREM: Have a seat. 23 MS. ALLEN: (Complies.)

JUDGE TOREM: Good morning, Ms. Allen,

- 1 MS. ALLEN: A little tired from the
- 2 drive, but I'm here.
- JUDGE TOREM: Okay. Did you understand
- 4 what I have explained to everybody else this morning?
- 5 MS. ALLEN: Yes, sir.
- 6 JUDGE TOREM: I understand All City
- 7 Movers was with another gentleman, Lyle Allen.
- 8 MS. ALLEN: Yeah, Eastside and All City
- 9 Movers.
- 10 JUDGE TOREM: Are you authorized to
- 11 represent the company?
- MS. ALLEN: Yes, I'm the owner of the
- 13 company. My husband -- well, soon to be ex, he's been
- in the business so many years, he knew the laws. I
- 15 was following in his footsteps. I am trying to -- I
- 16 have talked with her back, I believe, in October,
- trying to figure out what to do and how to comply.
- 18 Pretty much I have been veered off line --
- JUDGE TOREM: Okay.
- MS. ALLEN: -- with his -- with his old
- 21 ways.
- JUDGE TOREM: All right. So you are
- 23 here this morning to make sure the company gets into
- 24 compliance?
- MS. ALLEN: Yes, Your Honor.

- 1 JUDGE TOREM: And you have had a chance
- 2 to review the complaint that was filed?
- 3 MS. ALLEN: Yes.
- 4 JUDGE TOREM: How do you want to proceed
- 5 this morning?
- MS. ALLEN: Cease and desist.
- 7 JUDGE TOREM: All right. It sounds as
- 8 though you want to get the company into compliance.
- 9 Do you have a plan for doing that?
- 10 MS. ALLEN: Yes, I have been trying to
- 11 get ahold of our web designer, Jessica, UR Grafix, and
- 12 she has so many other clients. I have told her that
- we have to take the offering of move to labor-only,
- 14 that is what we had talked about, how to do it. As
- well as, I believe Craigslist should be off. I
- don't -- I haven't been on Angie's List in months,
- 17 since we had talked. I don't even know my passwords
- 18 on that, but I could still get it to where I shut it
- 19 down --
- JUDGE TOREM: Okay.
- MS. ALLEN: -- but some sites --
- JUDGE TOREM: What was the name of
- 23 the --
- MS. ALLEN: Huh?
- 25 JUDGE TOREM: What was the name of the

- web designer?
- MS. ALLEN: Jessica, UR Grafix.
- JUDGE TOREM: Okay.
- 4 MS. ALLEN: UR Grafix, G-R-A-F-I-X.
- JUDGE TOREM: Okay.
- 6 MS. ALLEN: That is her own website,
- 7 herself.
- 8 JUDGE TOREM: And you have been in touch
- 9 with her to let her know the website has to be
- 10 modified to offer moving services?
- MS. ALLEN: Yes, sir.
- 12 JUDGE TOREM: Are you also working with
- the Commission, then, to get a permit?
- 14 MS. ALLEN: I'm so baffled, I don't
- 15 understand some of the things, what I have to get. I
- do have a truck, it is -- it does have our name and
- 17 everything on it, but to get to the licensing up, I --
- 18 it's pricey for somebody just trying to get off the
- 19 ground.
- JUDGE TOREM: Understood. For today,
- 21 then, you understand that driving the truck would not
- 22 be labor-only?
- MS. ALLEN: Right. Yes, I understand.
- 24 Right now I have it, actually, at a storage unit for
- 25 advertisement.

1	JUDGE TOREM: Ms. Holloway, have you had		
2	a chance to talk with Ms. Allen leading up to today?		
3	MS. HOLLOWAY: Yes, we have talked.		
4	Staff supports a cease and desist order.		
5	JUDGE TOREM: Ms. Allen, any questions		
6	at this moment?		
7	MS. ALLEN: No, Your Honor.		
8	JUDGE TOREM: All right. So we are		
9	going to press on with the next person on the docket.		
10	I will have you work with Staff to get that drawn up.		
11	MS. ALLEN: Thank you.		
12	JUDGE TOREM: Next is Mr. Steven Ronald		
13	Erickson. This is Docket TV-140344.		
14	Mr. Erickson, I will swear you in, in case you		
15	want to give any testimony, and then I will take your		
16	counsel's appearance.		
17			
18	STEVEN R. ERICKSON, witness herein, having been		
19	first duly sworn on oath, was		
20	examined and testified as follows:		
21			
22	JUDGE TOREM: Please have a seat.		
23	MR. ERICKSON: (Complies.)		
24	JUDGE TOREM: Counsel, good morning.		
25	MR. PLOWMAN: Good morning, how are you?		

- 1 JUDGE TOREM: Tell us who you are.
- 2 MR. PLOWMAN: My name is Stephen
- 3 Plowman, S-T-E-P-H-E-N, bar number is 021823. My
- 4 residence -- or my office location is 8048 Northeast
- 5 Eighth Street, Medina, Washington 98039.
- JUDGE TOREM: All right, Mr. Plowman.
- 7 Thank you.
- 8 Have you had a chance to talk with your client
- 9 and understand exactly what this whole mover's court
- 10 is about?
- 11 MR. PLOWMAN: Yes, I think our direction
- this morning is to go with cease and desist.
- 13 Mr. Erickson's prior service consisted of some
- 14 pack-and-load operations. Began as a junk removal,
- 15 which, it was my understanding, didn't require a
- 16 license. But he has now -- and he's done some
- 17 furniture deliveries from commercial establishments to
- 18 residences. I'm not sure whether that -- I read the
- 19 statute this morning to see if that exactly complies.
- 20 I don't think that's point-to-point. He does want to
- 21 do point-to-point.
- MS. HOLLOWAY: Let me turn this on.
- MR. PLOWMAN: Am I singing now? Okay.
- 24 JUDGE TOREM: As long as that red light
- 25 is on it should pick up.

- 1 MR. PLOWMAN: It's not on.
- MS. HOLLOWAY: Okay, we've got it.
- JUDGE TOREM: All right. Good.
- 4 MR. PLOWMAN: Okay.
- JUDGE TOREM: Thank you.
- 6 MR. PLOWMAN: At any rate, there is a
- 7 desire to do point-to-point moving and he desires to
- 8 comply. The only way I see for it at this point is to
- 9 go ahead and do a cease and desist and then make his
- 10 application.
- 11 JUDGE TOREM: All right. And,
- 12 Mr. Erickson, you have had a chance to, I hope, get
- 13 the application paperwork?
- MR. ERICKSON: Yeah, we've got it.
- 15 JUDGE TOREM: Okay, excellent. Because
- while you are here today, like I said, the technical
- 17 assistance from the Staff, of experts that deal with
- 18 this on a day-to-day basis -- I certainly appreciate
- 19 how someone wants to get into business and doesn't
- 20 understand the complexity, so while you are here, ask
- 21 as many questions as you can.
- MR. PLOWMAN: Right. We will do that.
- JUDGE TOREM: All right. So we will get
- 24 a cease and desist order. I imagine Staff is
- 25 supportive of that?

25

1 MS. HOLLOWAY: Yes, Staff supports a cease and desist. 2 JUDGE TOREM: Mr. Plowman, you will see 4 there is essentially a form order, as you would see in Superior Court, that we have worked on. There is not 5 a block for your signature, but we can hand draw that 7 in. MR. PLOWMAN: That's fine. 8 JUDGE TOREM: We can adapt that. 9 10 Excellent. Thank you both for coming down 11 this morning. 12 MR. PLOWMAN: Thank you. 13 JUDGE TOREM: I have one other who is here this morning, Pro Moving Delivery, LLC, Alexander 14 Satir. This is Docket TV-140435. 15 16 17 ALEXANDER SATIR, witness herein, having been 18 first duly sworn on oath, was 19 examined and testified as follows: 20 21 JUDGE TOREM: Mr. Satir, can you spell your last name for me? 22 23 MR. ALEXANDER SATIR: S-A-T-I-R.

JUDGE TOREM: And I hear a bit of a

Russian accent. English is going to work okay this

- 1 morning, you understand what I have said?
- 2 MR. ALEXANDER SATIR: Sometimes. 50,
- 3 yeah.
- 4 JUDGE TOREM: My concern is that you
- 5 understand. If we enter an agreed order today, that
- 6 you know what you are signing.
- 7 MR. ALEXANDER SATIR: This is -- my son
- 8 is --
- 9 MR. DIMITRI SATIR: I will be helping
- 10 him translate.
- JUDGE TOREM: Okay, excellent.
- I didn't get a notice that we needed to
- 13 provide a translator. If your son is willing to act
- on your behalf, I just want to make sure that we
- 15 understand each other as we go forward this morning.
- 16 Can you state your name for the record?
- 17 MR. DIMITRI SATIR: Dimitri Satir.
- JUDGE TOREM: Dimitri Satir. Okay,
- 19 great.
- 20 Mr. Alexander Satir, again the question this
- 21 morning is the Commission has alleged that you are
- 22 operating a moving company and you don't have a
- 23 permit. Do you understand that?
- 24 MR. DIMITRI SATIR: Yes, he understands
- 25 that he is here because of that.

- 1 JUDGE TOREM: This morning the purpose
- of the hearing is to find out if you agree to stop
- 3 providing services without a permit.
- 4 Go ahead, Dimitri.
- 5 MR. DIMITRI SATIR: Yes, he wants to do
- 6 the cease and desist. The truck is broken right now.
- 7 Once he fixes the truck, he'll be selling the truck.
- 8 He wants to sell in 90 days, if possible.
- 9 JUDGE TOREM: So if you want to cease
- 10 and desist operating your business, that means there
- 11 would be no more offering to move, even when the truck
- 12 is fixed.
- 13 MR. DIMITRI SATIR: Yes. And I will not
- 14 be posting the advertisement. I have been not posting
- 15 advertisements on Craigslist for two months, I
- 16 believe. He understands that he won't have any ads.
- 17 JUDGE TOREM: All right.
- 18 Can I ask, Mr. Satir, if you are going to
- 19 continue with any sort of business that involves other
- 20 people's household goods?
- 21 MR. DIMITRI SATIR: He won't do it. He
- 22 won't be doing it for right now. Unless he wants to
- 23 come back, then he will come back and get a license.
- 24 If the situation changes, he will then come back and
- 25 open a license.

- JUDGE TOREM: All right. Thank you,
- 2 Mr. Satir.
- 3 Ms. Holloway, have you had a chance to work
- 4 with Mr. Satir and his son in understanding what was
- 5 going on today?
- 6 MS. HOLLOWAY: No, not necessarily. I
- 7 have checked and they are not advertising for
- 8 household goods anymore. Staff does support a cease
- 9 and desist.
- 10 JUDGE TOREM: All right. Mr. Satir, I'm
- 11 going to have you work with Ms. Holloway or other
- 12 Staff to draft that order. So your son -- it will be
- in English, so I will ask that he can walk through
- 14 that with you paragraph by paragraph, with Staff, and
- answer any questions. When we come back, before I
- 16 have you sign it, or before I sign it and approve it,
- 17 I want to make sure you understand what is happening
- 18 with it, okay?
- MR. DIMITRI SATIR: (Nods head.)
- JUDGE TOREM: Thank you. You can step
- 21 back.
- MR. DIMITRI SATIR: (Complies.)
- MR. ALEXANDER SATIR: (Complies.)
- 24 JUDGE TOREM: Those are the five
- 25 companies that came to Olympia this morning. I am

- 1 going to call out the ones that were not here yet
- 2 today.
- 3 Movers Plus and Joshua Washburn?
- 4 It's 10 minutes after 10:00 and they are not
- 5 here.
- 6 Man of Steel Movers, Michael Pandolfi? No
- 7 response.
- 8 Precision Moving Seattle, Christopher Dems?
- 9 And Cope Quality Services, Carrie Kreech?
- 10 Ms. Holloway, do you have any contact with any
- of those four companies leading up to this morning to
- 12 explain why they might not be here?
- MS. HOLLOWAY: Yes, Carrie Kreech has
- 14 sent a letter asking to do this proceeding by mail.
- 15 She is in training in California.
- Mr. Dems called this morning and said he is in
- 17 New York. The other two I haven't heard from.
- 18 JUDGE TOREM: Okay. I think I have had
- 19 some knowledge that Ms. Kreech had another career that
- 20 she had gone into and was in training. My
- 21 understanding is the Commission was pursuing an agreed
- 22 order with her by mail.
- MS. HOLLOWAY: Yes.
- 24 JUDGE TOREM: We will hold that case in
- abeyance, and we will deal with Mr. Dems, and see if

- 1 Mr. Washburn and Mr. Pandolfi have any further contact
- 2 after the break.
- MS. HOLLOWAY: Okay.
- 4 JUDGE TOREM: After we handle the people
- 5 that have done us the courtesy of coming down to
- 6 Olympia, we can entertain any motions for default.
- 7 MS. HOLLOWAY: Okay. Thank you.
- JUDGE TOREM: So the rest of you, at
- 9 this point, we are going to break here at about 10:15.
- 10 As soon as you have a chance to review the cease and
- 11 desist orders and the language with Staff, there will
- be, I imagine, some negotiation because Staff has
- 13 alleged previous violations and will want to seek
- 14 typically a penalty of some amount. It may be
- 15 nominal, depending on the history of your company, or
- 16 Staff may have a reason that some penalties are going
- 17 to be asked for higher than others.
- 18 Typically, what is asked for is also that some
- other part of the penalty that's authorized by law be
- 20 suspended. It's an approach to keep you remembering
- 21 that if you had to pay a couple hundred dollars today,
- 22 you might have pay a couple thousand if you violate
- the order, and to keep you on the straight and narrow.
- 24 So that's the typical approach. You can expect that.
- 25 If you cannot make a payment on the full

- 1 penalty, some arrangement can be made. There are some
- 2 limitations based on our accounting here at the
- 3 Commission. I will leave Staff to explain those
- 4 things to you.
- 5 Hopefully by 10:45 or eleven o'clock, all five
- of you will have your orders prepared. We will call
- 7 you back up, make sure you understand it, sign it on
- 8 the record today, and you will leave with a printed
- 9 copy of the order, and probably then later get one in
- 10 the mail on our official service.
- 11 Ms. Holloway, anything else before we take our
- 12 break?
- MS. HOLLOWAY: No.
- 14 JUDGE TOREM: By a show of hands, does
- anybody have any questions before we recess the
- 16 hearing?
- Not seeing any, at 10:15 we are at recess.
- 18 Ms. Holloway, let me know when I need to come
- 19 back and be on the Bench.
- MS. HOLLOWAY: Thank you.
- JUDGE TOREM: Thank you all again for
- 22 coming down. See you in about 45 minutes.
- 23 (A brief recess.)
- 24 JUDGE TOREM: All right. Good morning.
- 25 I understand that the cease and desist orders have

- 1 been explained and presented to all of the individual
- 2 movers. I will call you back up one at a time. It is
- 3 now 11:15. Hopefully this will go quickly and get you
- 4 back on with your day. We will just go in the same
- 5 order we were before.
- 6 Jonathan Jorde. This is Docket TV-140339.
- 7 Mr. Jorde, did you have a chance to walk
- 8 through this multipage order and understand? It's
- 9 probably a little bit repetitive or redundant, but for
- 10 our purposes, an initial order has to have a
- 11 stand-alone document, if you will, that has all of the
- 12 facts that are relevant and then all of the
- 13 stipulation, what has been agreed to. We have to have
- 14 findings of fact and conclusions of law. All of that
- 15 legal mumbo jumbo has to be in there.
- 16 I'm looking through it and I see that you have
- 17 signed it. Did you understand all the five pages
- 18 prior to the signature?
- 19 MR. JORDE: Yes, Your Honor.
- JUDGE TOREM: Just for the record, what
- 21 it looks like, Ms. Holloway, you have recommended in
- 22 this case two violations: One for offering a move and
- 23 one for advertising?
- MS. HOLLOWAY: Yes, that's correct.
- JUDGE TOREM: And that \$5,000 penalty,

- with the majority, \$4500 of that be suspended, and a
- 2 \$500 penalty be imposed on Queen City Movers and
- 3 Jonathan Jorde; is that correct?
- 4 MS. HOLLOWAY: Yes, that is correct.
- JUDGE TOREM: Mr. Jorde, any dispute
- 6 about the facts as we talked about earlier?
- 7 MR. JORDE: No, Your Honor.
- 8 JUDGE TOREM: And again just for the
- 9 record, that you are agreeing to shut down Queen City
- 10 Movers until and unless you get a permit?
- MR. JORDE: Yes, Your Honor.
- 12 JUDGE TOREM: And the suspension period
- on that penalty, the \$4500, is for two years from
- 14 today's date. So it being May 6th, 2014, we are going
- to carry this out to May 6, 2016. Hopefully we don't
- see each other again between now and then.
- 17 The penalty of \$500, did you have a -- I don't
- 18 see a penalty schedule sketched out here. Do you have
- 19 a plan for when you were going to make a payment on
- 20 that?
- 21 MR. JORDE: I don't have any money, Your
- 22 Honor, but I did -- they were just going to take my
- 23 application fee and use that, which is \$500.
- 24 JUDGE TOREM: So essentially paying the
- 25 penalty to pay the application fee. Is that what

- 1 Staff's understanding is as well?
- MS. HOLLOWAY: Yes, he is using the
- 3 money that he previously used for application fee and
- 4 applying it towards the penalty.
- 5 JUDGE TOREM: All right. I think that's
- 6 a constructive use for compliance. It doesn't unduly
- 7 penalize someone who is trying to get their company up
- 8 and running.
- 9 Any questions about the order, then?
- 10 MR. JORDE: No, Your Honor.
- 11 JUDGE TOREM: I will sign it. Is there
- 12 an indication somewhere in this order, Ms. Holloway,
- then, that that penalty is being applied, the
- 14 application fee is being applied, or should I
- 15 handwrite that into Appendix A?
- MS. HOLLOWAY: If you would like to
- 17 handwrite it, that would be fine. There is nothing in
- 18 the order stating that.
- 19 JUDGE TOREM: All right. So I'm just
- 20 going to put down that that Respondent's application
- 21 fee will be applied toward the penalty, that way there
- 22 is no question from Financial Services, that there is
- 23 some outstanding penalty. I don't want Mr. Jorde to
- 24 be pursued unnecessarily for something that we have
- 25 agreed is essentially paid.

- 1 MS. HOLLOWAY: We have discussed this
- 2 with financial services this morning.
- 3 JUDGE TOREM: All right. I will make a
- 4 note of that on Appendix A, on the page here, and
- 5 initial that.
- 6 Mr. Jorde, I will make sure you get a copy of
- 7 this on the way out. I am going to hand this back to
- 8 Staff at this point. Thank you very much.
- 9 Do you have any further questions?
- 10 MR. JORDE: Am I free to leave, Your
- 11 Honor?
- 12 JUDGE TOREM: If you would like to get a
- 13 copy of this before you go, fantastic; if not, you are
- 14 free to go.
- MR. JORDE: Okay. Yeah, I don't need a
- 16 copy. They can mail it to me. They have my address.
- JUDGE TOREM: We will make sure that a
- 18 copy goes out. We do send it out by mail.
- 19 MR. JORDE: Okay. Thank you, Your
- Honor.
- JUDGE TOREM: Thank you, Mr. Jorde.
- The next case is TV-140340. This is Sea-Tac
- 23 Movers, LLC, Doyin Adekanmbi.
- 24 Mr. Adekanmbi, from the brief review I have
- 25 made of the document, it looks like it is the same

- 1 situation we had with the last case. Did you have a
- 2 chance to review the entire order?
- 3 MR. ADEKANMBI: No, I didn't, but I
- 4 trust Ms. Holloway's...
- 5 JUDGE TOREM: I'm looking and I see your
- 6 signature on the back page here, Page 5 of the order.
- 7 What I want to make sure is you understand that you
- 8 are agreeing that you are not going to be in a moving
- 9 business. Again, if you are in a pack-and-load
- 10 business and it's entirely clear, then there won't be
- 11 any issues with the order.
- MR. ADEKANMBI: Right.
- 13 JUDGE TOREM: But if you stray back into
- 14 moving -- what you are agreeing to do here is pay a
- 15 \$500 penalty for your previous violation. You are
- 16 agreeing that the remainder of the penalty that Staff
- is recommending, again \$5,000 total, 500 of which you
- 18 are responsible for, but \$4,500 is held in abeyance
- 19 for two years. As long as you understand that if you
- are out moving again within the two-year period, you
- 21 can automatically be subject to that penalty. If you
- don't pay it, the Commission sends it to collections,
- 23 and then eventually to Superior Court. We like to
- think we are friendly here, but it's a little
- 25 different procedure in Superior Court.

- I just want to make sure you understand that's
- what you are agreeing to do, is stop the moving
- 3 business, pay the \$500, and remember not to go back
- 4 into moving for at least two years.
- 5 MR. ADEKANMBI: Yes, sir.
- 6 JUDGE TOREM: Now, your order has a
- 7 payment schedule: Essentially one-third of it being
- 8 paid today, another month from now paying another
- 9 third, and then paying it off by July 6th.
- 10 MR. ADEKANMBI: Yes, Your Honor.
- JUDGE TOREM: I think July 6th may
- 12 actually be a Sunday.
- MR. ADEKANMBI: It is.
- 14 JUDGE TOREM: So you will want to make
- 15 sure you have it here before the 4th of July holiday
- 16 weekend, so that there is no question that it was late
- or for some reason --
- 18 MR. ADEKANMBI: It will probably be
- 19 taken care of next month.
- JUDGE TOREM: Okay. When I hear someone
- 21 say "it will probably be taken care of," that assures
- 22 me that you are intending to do it. What I want to
- 23 tell you is if you run into any difficulty with these
- 24 payment dates, if the Commission hears from you before
- 25 the date passes, that's better than hearing from you a

- 1 week late, when the Commission may be getting ready to
- 2 call you. The easier you make it on us to understand
- 3 your individual circumstance the better.
- 4 Again, our goal is compliance. What we are
- 5 looking for is, when I sign this order and send you on
- 6 your way today, that you will have made the first
- 7 payment, make the second on time or maybe early,
- 8 that's always better, and if you are going to be late,
- 9 tell us before we realize you are late.
- 10 MR. ADEKANMBI: Yes, Your Honor.
- JUDGE TOREM: Did you get your questions
- 12 answered as well about what is legal and what is not?
- MR. ADEKANMBI: Yes, Your Honor, and I
- 14 will be in touch.
- 15 JUDGE TOREM: I want to make sure, while
- 16 you are here in Olympia today, that if there is some
- 17 question that can be answered, it is, so that you are
- 18 entirely clear what is keeping you within the lines.
- 19 MR. ADEKANMBI: So as long as -- well,
- 20 we did the cease and desist. Does that mean just
- 21 totally stop, even in the pack section, or --
- 22 MS. HOLLOWAY: No, you can still perform
- 23 pack-and-load, you just can't use a truck to move.
- 24 MR. ADEKANMBI: Okay. And as long as
- 25 everything is clear, ads, website, no -- like you

- 1 said, as long as a layman can tell that I do not --
- MS. HOLLOWAY: Do not provide a truck.
- 3 If anyone calls you, do not offer a truck.
- 4 MR. ADEKANMBI: Under any circumstance.
- JUDGE TOREM: Ms. Holloway has other
- 6 Staff that are working in that compliance division
- 7 now.
- MR. ADEKANMBI: Okay.
- 9 JUDGE TOREM: If you want to make sure
- 10 your ad is not going to run afoul of the Commission's
- 11 rules and regulations, and you have a chance to send a
- draft to one of the enforcement Staff first, that's
- 13 probably a great idea, before you pay to put it up and
- 14 then have one of our staff run across it. They can
- 15 tell you if the language meets with Commission rules
- 16 and will keep you out of trouble.
- 17 MR. ADEKANMBI: I mean to be honest, I
- 18 want to backburn [sic] inside of the moving industry.
- 19 I mean like anyone knows, it's a lot of work. Being
- in three states, it has taken a toll. I also have a
- 21 full-time job contracting with the Department of
- 22 Education. It's -- it's -- I will be in compliance.
- JUDGE TOREM: It is easier, but I want
- 24 to make sure that you understand. Commission Staff,
- 25 from what I understand, they want to be more on the

- 1 help side than they do on the enforcement side. If
- 2 you call us first, and I appreciate your attitude,
- 3 they are here to help and keep you out of being in
- 4 this courtroom again, ever again. Your time is
- 5 valuable with all the other things you have got going
- 6 in multiple states and now another job as well.
- 7 That's why I say while you are here today, get your
- 8 questions answered.
- 9 I have signed the order. If you want to wait
- 10 to get a copy of it, that's great. If you want to
- 11 wait for it to come in the mail, we will send it to
- 12 the same address we sent the subpoena and complaint.
- 13 It should be to you shortly, okay?
- MR. ADEKANMBI: I appreciate that.
- 15 Thank you for your time.
- JUDGE TOREM: Thank you.
- 17 Next matter is TV-140342. This is All City
- 18 Movers and Darcy Allen.
- 19 Welcome back, Ms. Allen. I see that you have
- 20 signed the stipulated order. Ms. Holloway told me
- 21 each of the cases is essentially the same at this
- 22 point. They have all agreed for a cease and desist
- 23 for a payment of the \$500. For your schedule, it is
- 24 similar to what I just described: One third due
- 25 today, a month from now, and then prior to the

- 1 July 4th weekend.
- MS. ALLEN: Yes.
- JUDGE TOREM: Is that suitable to you?
- 4 MS. ALLEN: Yes.
- 5 JUDGE TOREM: And you understand what
- 6 you can and can't do with --
- 7 MS. ALLEN: Yeah, I was listening to
- 8 his. It's pretty much the same thing. I can do a
- 9 pack-and-load. I have to go to the site, I can unload
- 10 for them.
- JUDGE TOREM: Right. Labor-only is
- 12 outside of the household goods requirement for a
- 13 permit.
- MS. ALLEN: Okay. That scared for me
- 15 for a second there.
- 16 JUDGE TOREM: If you are doing the
- 17 driving --
- MS. ALLEN: Right, that's --
- 19 JUDGE TOREM: If you are providing the
- 20 truck, if you are renting the truck on their behalf,
- 21 we're getting into a gray area. That means you are
- 22 going to need a permit. If they have acquired the
- 23 truck and you just help load it, you help unload it at
- the other end, as Ms. Holloway said, that's going to
- 25 be within the realm of not needing a permit.

- 1 Now, you said earlier you are trying to get
- the company squared away. Have you got a plan for
- 3 applying for a permit when you are ready?
- 4 MS. ALLEN: Yeah, I have -- with the
- 5 packet that you guys had sent us, it's in there. I
- 6 just need to know like procedure-wise for -- to get
- 7 the DOT for the truck, for my truck, and what
- 8 insurance companies are available. I have called
- 9 around and a lot of them are like -- you know, they
- 10 don't want to deal with us. I'm just having -- if I
- 11 could have some assistance or some feedback on the
- 12 companies.
- 13 JUDGE TOREM: I'm not sure that we are
- 14 allowed to endorse any particular commercial
- 15 companies. However, I think that there may be some
- other references that our Staff can provide.
- MS. ALLEN: Okay.
- 18 JUDGE TOREM: Honestly, I haven't got
- 19 that far down in the weeds.
- 20 Any other questions about what is legal and
- 21 what is not legal with or without a permit?
- MS. ALLEN: No, I have -- I have pretty
- 23 much a good understanding.
- 24 JUDGE TOREM: And as I went over the
- 25 order with the previous companies, you are agreeing to

- 1 pay the penalty on the schedule we just talked about?
- MS. ALLEN: Yes.
- 3 JUDGE TOREM: You understand that the
- 4 remaining part of the penalty that is suspended, a
- 5 total of \$4500, is out there for two years?
- 6 MS. ALLEN: Yes, Your Honor.
- 7 JUDGE TOREM: Hopefully that is an
- 8 incentive to keep things in the straight and narrow
- 9 and not come back or be pursued to be asked to pay
- 10 that. That, I think for a lot of small companies, is
- 11 a pretty big number.
- MS. ALLEN: It is.
- JUDGE TOREM: And if I recall correctly,
- 14 the advertisements you have said you have done your
- 15 best to make sure they are down.
- 16 MS. ALLEN: Yes. I also just talked to
- 17 Jessica and told her that she had to make sure she
- 18 goes over all the wording and edit everything that has
- 19 to deal with pretty much traveling.
- 20 JUDGE TOREM: Excellent. I hope that
- 21 the web designer you are in touch with, she is able to
- 22 take the page down that is violating the rules right
- 23 now. If it is a pack-and-load website, if it's a
- labor-only website, that will be just fine.
- MS. ALLEN: Okay.

- 1 JUDGE TOREM: And as I suggested
- 2 earlier, if you want to run the draft of the web
- 3 design by the compliance folks here and make sure they
- 4 don't have any problems with it --
- 5 MS. ALLEN: Yeah.
- 6 JUDGE TOREM: -- it would probably be
- 7 easier to do in advance.
- 8 MS. ALLEN: I will be doing that.
- JUDGE TOREM: I have signed the order.
- 10 Any other questions for me?
- MS. ALLEN: No, sir.
- 12 JUDGE TOREM: Ms. Holloway, I will hand
- 13 this down to you.
- MS. ALLEN: Thank you.
- JUDGE TOREM: Thank you, Ms. Allen.
- Next is Mr. Erickson, Docket TV-140344.
- 17 Mr. Erickson, have had a chance to go over
- this with your attorney, Mr. Plowman?
- MR. ERICKSON: Yes, I did.
- JUDGE TOREM: And I see that you have
- 21 signed for here and there is not a payment schedule,
- 22 so there has been some other arrangement made for the
- 23 penalty recommended by Staff?
- MR. ERICKSON: Yes, we are going to pay
- 25 in full today.

- 1 JUDGE TOREM: Sometimes it's good to get
- 2 it taken care of right away.
- 3 Mr. Plowman, have you had a chance to review
- 4 the order as well?
- 5 MR. PLOWMAN: We reviewed the entire
- 6 order.
- JUDGE TOREM: Any questions or anything
- 8 else that we need to put on the record?
- 9 MR. PLOWMAN: I don't think so. We
- 10 understand.
- JUDGE TOREM: Ms. Holloway, anything to
- 12 add from Staff?
- MS. HOLLOWAY: No.
- JUDGE TOREM: All right. With the
- 15 benefit of counsel, I am not going to belabor it. I'm
- just going to get this signed and get you on your way
- 17 back north.
- 18 MR. PLOWMAN: Thank you, Your Honor.
- JUDGE TOREM: Thank you both for your
- 20 time this morning.
- MR. PLOWMAN: Thank you.
- JUDGE TOREM: The last case that is
- 23 present this morning is Docket TV-140345. This is
- 24 Alexander Satir.
- 25 Mr. Satir and Dimitri, if you would come back

- 5 \$500 penalty. There is no schedule for payment.
- 6 MR. DIMITRI SATIR: Yes, all today.
- 7 JUDGE TOREM: So you are going to pay
- 8 the \$500 today?
- 9 MR. DIMITRI SATIR: Yes.
- 10 JUDGE TOREM: Do you have any questions
- 11 about the order?
- MR. DIMITRI SATIR: No.
- JUDGE TOREM: I'm going to sign the
- order and make sure you have a copy before you leave.
- 15 MR. ALEXANDER SATIR: Thank you.
- JUDGE TOREM: If you have questions
- about what you can or can't do with the truck or with
- 18 the moving company, please be in touch. If we need a
- 19 translator, an interpreter to provide answers to your
- 20 questions in the future, let us know. We can find a
- 21 Russian interpreter if your son is not available.
- MR. ALEXANDER SATIR: Okay. Thank you.
- JUDGE TOREM: Thank you for coming down.
- 24 I appreciate your patience.
- 25 That exhausts the companies that are present

- in the hearing room today. It is now a little after
- 2 11:30. I am going to call the remaining companies
- 3 that haven't appeared and had no contact with the
- 4 Commission, to make sure that they are not present by
- 5 some -- something unknown to myself or Staff.
- 6 Docket TV-140338. This is Movers Plus and
- 7 Joshua Washburn. Still not present.
- 8 Docket TV-140341, Man of Steel Movers and
- 9 Michael Pandolfi. Also still not present.
- 10 Ms. Holloway, you told me that Docket
- 11 TV-140343, Precision Moving Seattle, Christopher Dems,
- 12 that company had contact with you earlier; is that
- 13 correct, they are in New York City?
- MS. HOLLOWAY: Yes, he contacted me and
- 15 said he was in New York City and not able to attend
- 16 the hearing today.
- JUDGE TOREM: When did he first let you
- 18 know that he couldn't be here today?
- MS. HOLLOWAY: Today.
- JUDGE TOREM: In his case, when was the
- 21 subpoena served?
- MS. HOLLOWAY: It was served on
- 23 March 27th, 2014.
- 24 JUDGE TOREM: So approximately six weeks
- 25 ago?

- 1 MS. HOLLOWAY: Yes.
- JUDGE TOREM: And you had no further
- 3 contact with him until the phone call this morning?
- 4 MS. HOLLOWAY: I left him a voicemail
- 5 asking him, approximately two weeks ago, if he would
- 6 be in attendance. He left me a voicemail saying that
- 7 he would be here in attendance.
- 8 JUDGE TOREM: And then suddenly this
- 9 morning he is in New York?
- 10 MS. HOLLOWAY: And this morning he
- 11 called me and said that he would be in New York.
- 12 JUDGE TOREM: All right.
- MS. HOLLOWAY: In my voicemail I left
- very specific instructions, that he should be,
- otherwise the default order would be entered and he
- would be responsible for a \$5,000 penalty.
- JUDGE TOREM: So I have had a chance to
- review in those three dockets, 140338, 140341 and
- 19 140343, the Commission's evidence, that there was a
- 20 move offered for intrastate move in Washington and
- 21 there was advertising that meets the definition of
- 22 RCW 81.80.075, as engaging in moving without a
- 23 household goods permit.
- 24 Also, there is no evidence that any of these
- 25 companies have a permit under any other status; is

- 1 that correct?
- MS. HOLLOWAY: No, none of them do.
- JUDGE TOREM: So what is the
- 4 Commission's motion at this point with these three
- 5 companies?
- 6 MS. HOLLOWAY: The Commission's motion
- 7 is that we enter a default order with the penalty of
- 8 \$5,000 for each one of these companies.
- 9 JUDGE TOREM: All right. So nothing
- 10 would be suspended. Essentially they would be default
- 11 orders finding them in default for failure to show up
- 12 today, and also taking the Commission's evidence as a
- 13 prima fascia case, that they were operating without a
- 14 permit.
- MS. HOLLOWAY: Yes, that's correct.
- JUDGE TOREM: And imposing the full
- 17 \$5,000 penalty for the two alleged violations. That's
- 18 essentially the same violation alleged in each
- 19 company's case?
- MS. HOLLOWAY: Yes.
- JUDGE TOREM: I will grant that motion
- 22 for those three companies. That's for Movers Plus,
- Joshua Washburn in 140338, for Man of Steel Movers,
- 24 Michael Pandolfi in 140341, and I am also granting the
- 25 motion in Mr. Christopher Dems' case, Precision Moving

- 1 Seattle, 140343.
- 2 If you will present me with the appropriate
- default orders, I will sign all three of those later
- 4 this morning.
- 5 MS. HOLLOWAY: Okay.
- 6 JUDGE TOREM: Now, in the matter of
- 7 Carrie Kreech and Cope Quality Services, TV-140345, it
- 8 appears that she has made some good faith efforts with
- 9 the Commission, from what you described earlier.
- 10 MS. HOLLOWAY: Yes, she sent a letter to
- 11 the Commission and she has also sent a letter, or her
- 12 employer has sent a letter saying that she was ordered
- 13 to be in training in California today.
- 14 She was sent a stipulated order to sign. I
- asked her to return it to me before today. I haven't
- seen it yet. That doesn't necessarily mean it's not
- 17 here somewhere.
- 18 JUDGE TOREM: All right. So it is
- 19 possible that she is returning the order and it didn't
- 20 make it back today. What is the Commission's position
- 21 going to be, if we are not going to take action on the
- 22 case today, if the order is not received in the next
- 23 day or week?
- MS. HOLLOWAY: I believe we gave her the
- 25 option of either getting that order in today or moving

- 1 her to the next mover's court, which won't be until
- 2 October 2014. I don't think we are going to ask for a
- 3 default order at this time.
- 4 JUDGE TOREM: So hopefully it's in the
- 5 mail and it's on its way here. My recommendation is
- 6 that you check with Ms. Kreech next week, when she is
- 7 back from her training, and ask her if she is planning
- 8 to submit that order. If she is not, that Staff file
- 9 a letter for the docket number, explaining what did or
- 10 didn't happen, and making sure that the next mover's
- 11 court in October, or whenever it is scheduled, she is
- 12 either on the docket or there is a record of what
- occurred today, without having to rereview the
- 14 transcript.
- MS. HOLLOWAY: Okay.
- JUDGE TOREM: Any other business for
- 17 what we are doing this morning?
- 18 MS. HOLLOWAY: No, that's everything.
- 19 JUDGE TOREM: All right. So I will look
- 20 for those three orders later today and get those
- 21 entered. Thank you very much. We are adjourned at
- 22 11:40.
- MS. HOLLOWAY: Thank you.
- 24 (Mover's Court adjourned 11:40 a.m.)
