CLAIM OF CONFIDENTIALITY

Under covering letter dated August 1, 2014, Western Wahkiakum County Telephone Company ("Company") submitted to the Washington Utilities and Transportation Commission ("Commission") for filing the Company's Petition to Receive Support from the State Universal Communications Services Program established by RCW 80.36.650 ("Petition"). Two versions of the Petition were included in that filing, one labeled as "unredacted," and the other labeled as "redacted."

Since submission of above-mentioned filing, the Company has discovered that the last eight (8) pages of the unredacted version of Exhibit 5 to the Petition were inadvertently omitted from the filing. In addition, as a result of review by the Commission Staff, it has been determined that revisions to Exhibits 4 and 7 to the Petition are also in order. Accordingly, accompanying this letter are one set of unredacted copies of the eight (8) pages that were inadvertently omitted from the above-mentioned Exhibit 5, which should be added at the end of Exhibit 5, as previously included in the "unredacted" version of the Petition. The Company respectfully requests that they be so added, and that they be treated as being subject to the claim of confidentiality that was set forth in the Company's above-mentioned letter of August 1, 2014. In accordance with WAC 480-07-160(3)(c), for purposes of the paper version that is being filed, they have been printed on yellow paper and have been enclosed in a separate, sealed envelope labeled "Confidential per WAC 480-07-160."

Also accompanying this letter are six (6) copies of a revised Exhibit 4 to the Petition. These are intended to replace and supersede the six (6) copies of Exhibit 4 that

were included in the Company's initial filing in this docket. Two (2) of the copies are intended to be included in the "original" redacted and unredacted versions of the Petition, respectively, while the remaining four (4) copies are intended to be included in the "copies" of the unredacted version of the Petition that were previously submitted. The revised Exhibit 4 reflects data entry changes that have been made on pages 4, 6 and 7 of the Financial Statement Template. ¹

Lastly, accompanying this letter are six (6) copies of a revised Exhibit 7 to the Petition, reflecting a modified presentation of corporate operations expense adjustment(s). These copies are intended to replace and supersede the six (6) copies of Exhibit 7 that were included in the Company's initial filing in this docket. Two (2) of the copies are intended to be included in the "original" redacted and unredacted versions of the Petition, respectively, and the remaining four (4) copies are intended to be included in the "copies" of the unredacted version of the Petition that were previously submitted

The exhibits or portions of exhibits that accompany this letter are intended to be covered by the officer certificate set forth on page 5 of the Petition as originally submitted, and are hereby made subject thereto.
