Amending Certificate C-001052.	AMENDING CERTIFICATE C-1052 TO REFLECT LOAN SATISFACTION OF MORTGAGED CERTIFICATE.

**BACKGROUND**

- 1 On May 12, 2016, Beeline Tours Ltd. d/b/a Seattle Express (Beeline or Company) filed with the Washington Utilities and Transportation Commission (Commission) an application pursuant to RCW 81.68.040 for authority to mortgage Certificate of Public Convenience and Necessity No. C-1052 for operation of its auto transportation company.
- 2 This matter came before the Commission at its regularly scheduled meeting on September 22, 2016. Staff reviewed the application in Docket TC-160497 and recommended the Commission grant the authority to mortgage C-1052.
- 3 Order 01 was approved on September 22, 2016, and certificate C-1052 was amended to include the following:

THIS CERTIFICATE SUBJECT TO MORTGAGE IN FAVOR OF  
MILLER SCHMER, INC. AS SECURITY PAYABLE TO SAID  
SECURED PARTY IN THE COMBINED PRINCIPAL AMOUNT  
OF \$418,000 BY COMMISSION ORDER TC-160497 DATED  
SEPTEMBER 22, 2016.
- 4 On February 14, 2025, Beeline Tours LTD submitted a letter notifying the Commission of the release of its mortgage and requested that the Commission amend its certificate to remove the language concerning the mortgage from certificate C-1052. A notarized certificate of loan satisfaction was included with the letter.

5 The mortgage has been satisfied and the language noted in the certificate is no longer  
relevant for the purpose of regulation.

### DISCUSSION AND DECISION

6 Beeline is a public service company subject to Commission jurisdiction pursuant to RCW  
81.68.

7 The Commission grants the request from Beeline Tours LTD. The Commission has  
reviewed certificate C-001052 and finds that the language in item 3 is no longer valid,  
and the certificate should be amended to reflect the satisfaction of the mortgage.

8 Beeline Tours LTD has satisfied the Commission's requirements in Order 01.

### ORDER

#### THE COMMISSION ORDERS:

- 9 (1) Beeline Tours LTD has satisfied the mortgage and provided evidence of the  
mortgage release as required in Order 01.
- 10 (2) Certificate C-1052 is amended accordingly.

The Commission has delegated authority to the Secretary to enter this Order under RCW  
80.01.030 and WAC 480-07-905(6)(c).
