FIELD CASE REPORT

NARRATIVE

At 05:05 Hrs. on January 31st, 2017 I was dispatched to the area of the Wallula Train Yard in reference to a possibly injured man on the train tracks located there. While enroute dispatch further advised that the injured person had possibly severed a leg as well.

Upon arrival Walla Walla County District 5 medical personnel were already on scene, but had not yet made their way to the victim. I first contacted Dumont, Arthur A (4b) who advised me that he was the one who had located the victim, later identified as Schneider, John P. (4b) Arthur stated that he had gone back to look for John at which time he noticed a light coming from under one of the train cars. Arthur stated that he had made his way towards that light at which time he discovered John and immediately called for help. Arthur, who appeared visibly shaken, stated that he was unsure if John was still alive, but he had appeared to have lost a leg.

Deputy Maas, District 5 personnel and I then began making our way towards the location reported by Arthur. Upon locating John, it was obvious that he was deceased.

I photographed John and the surrounding scene as I found it; those photos were submitted with the report.

Due to this being a Union Pacific employee on Union Pacific property, I asked dispatch to notify Union Pacific investigators and have them respond to the scene. I further asked dispatch to contact the Walla Walla County Coroner as well.

Upon their arrival the scene was subsequently turned over to the Walla Walla County Coroner and representatives from Union Pacific.
