- On August 24, 2017, David Stanzak, on behalf of the Estate of Doreen L. Hodin, filed with the Washington Utilities and Transportation Commission (Commission) a formal complaint against Avista Corporation (Avista or Respondent) alleging that Avista has refused to restore electric and gas service to Ms. Hodin's former property in violation of Revised Code of Washington (RCW) 80.28.110 and Washington Administrative Code (WAC) 480-100-123 (Complaint).
- On August 31, 2017, Avista filed a response to the Complaint explaining that the Company requires an electrical inspection by the Washington State Department of Labor and Industries before it will restore service to the property. Avista further explains that it has offered to reimburse Mr. Stanzak for the cost of the inspection.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for resolving the issues in this matter.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, February 20, 2018, on the Commission's conference bridge line.
